 - A. Regulatory Zone Amendment Case No RZA10-002 Crosby Lodge Review and recommendations on the request to change the regulatory zone on three parcels (APN 079-230-04, 07 and 11), totaling 20.59 acres, from General Rural (GR) to Specific Plan (SP) located at the northwest corner of Sutcliff Drive and Jigger Bob, in the town of Sutcliffe as authorized in Article 821, Amendment of Regulatory Zone. These parcels located in Commission District 4 within Section 15, T24N, MDM, Washoe County, Nevada and are completely surrounded by the Pyramid Lake Paiute Tribes' Reservation.  - A Sparks Energy Park and Reno Technology Park Special Use Permit Applications
 - Special Use Permit SW11-001 (Sparks Energy Park) Continued discussion and possible recommendations on the request to construct a 360 megawatt combined cycle natural gas power plant, substation, transmission line and associated grading to support the construction of a technology park. The project constitutes a project of regional significance per Nevada Revised Statutes (NRS) 278.026(5)(d)(5) and NRS 278.026(6)(a) through (e). Additionally, this project falls under the Hazardous Materials provision of Washoe County Development Code (110.810.42).

2. Special Use Permit SW11-002 for Water Storage Tanks (Reno Technology Park and Sparks Energy Park) – Continued discussion and possible recommendations on the request to construct two new one-million gallon water tanks and related piping to serve the future energy facility and information center.

3. Special Use Permit SW11-003 (Reno Technology Park) – Continued discussion and possible recommendations on the request to establish a data center and related facilities to include buildings, grading, private roads and utilities within a gated technology park.

These parcels are located in the East Truckee Canyon directly north of I-80 north of the Tracy Power Plant (APN: 084-030-20; 084-110-08; 084-110-05; 084-110-20; 084-211-01; 084-191-01; 084-191-03; 084-191-06; 084-191-05), encompass ±2,226 acres, and are situated within the Truckee Canyon Area Plan. The anticipated Washoe County Regulatory Zones are: Industrial, Tourist Commercial & General Rural. (The subject property shall be rolled back from the City of Sparks sphere of influence and into Washoe County prior to the Washoe County Planning Commission meeting.) These requests are authorized in Article 810, Special Use Permits in the Washoe County Development Code, are in Commission District 4, within Sections 29, 30, 31 & 32, T20N R22E MDM, Washoe County, Nevada.
