Special Use Permit Case No. SB11-009 Granite Construction Aggregate Facility Review and recommendations on the request to continue sand removal and screening operations for the portion of the aggregate facility that is within the boundaries of Washoe County located in Wadsworth, NV, which began operations in 1998 under SPB7-15-98 and was renewed under SB04-011 by the Board of Adjustment in 2004. The parcel is located North of I-80 along State Route 427, approximately 388 feet northeast of the intersection of Lincoln Highway and State Route 427 (APN-084-640-01, -02, -03, -06, -07; 084-220-40, -41, -42), and is 128.88-acres in size, is zoned General Rural (GR) and Medium Density Suburban (MDS), is located within the Truckee Canyon Area Plan. This request is authorized in Article 810, Special Use Permits in the Washoe County Development Code, is in Commissioner District 4, within Section 3, T20N, R24E, MDM, Washoe County, NV.
