Minutes of the regular meeting of the East Truckee Canyon Citizen Advisory Board held March 7, 2012 at the Stampmill Neighborhood Fire Department, Station 25, 400 Stampmill Dr., Wadsworth, Nevada

- 1.\* CALL TO ORDER/PLEDGE OF ALLEGIANCE The meeting was called to order at 7:12 p.m. by Bambi Van Dyke, Chair. Ms. Van Dyke led the pledge of allegiance.

  - A.\* REMSA UPDATE Jim Gubbels, RN, BSN, Chief Administrative Officer, REMSA presented information regarding emergency medical service to the East Truckee Canyon Citizen Advisory Board planning area as well as the Silver Savers program. Mr. Gubbels reported on staffing coverage for the two twelve hour shifts. Mr. Gubbels provided brochures for enrollment into the ground services program. The program covers all members of the household. Mr. Gubbels also provided information on care-lift program. Mr. Gubbels stated that he would be back to the ETCCAB in the fall with applications for the 2013 Silver Savers program. (This item was informational only and no action was taken by the CAB.)

## **Comments and Concerns**

- Concerns were raised regarding local coverage during shift changes and during medical emergency transport into Reno. A concern was stated that in the past, crews didn't show up until mid-afternoon.
- Mr. Gubbels stated that with the new procedure, local emergency medical services have increased. The twelve hour shifts are beneficial to the community as well as emergency service personnel. Mr. Gubbels also stated that they do have mutual aide agreements to cover emergencies.
- Mr. Gubbels stated that REMSA has ground and air transport emergency services.
- Concerns were raised that Washoe County red-flagged the trailer that was on-site so it had to be removed.
