Those items marked with an asterisk (*) may be discussed but action will not be taken on them.

Possible changes to the agenda order and timing. Discussion may be delayed on any item on this agenda, and items on this agenda may be taken out of order, combined with other items and discussed or voted on as a block, removed from the agenda, moved to the agenda of another later meeting, and/or moved to or from the consent section. Items designated for a specified time will not be heard before that time, but may be delayed beyond the specified time.

Public Comment; disrupting of meeting. During the "Public Comment" periods listed below, anyone may speak pertaining to any matter either on or off the agenda. The project is located at 31850 Cantlon Drive, in the Wadsworth area. The ±5.94 acre parcels is zoned Medium Density Rural in the East Truckee Canyon Area Plan and is situated in portions of Sections 17 and 18, T20N, R24E, MDM, Washoe County, Nevada. The property is located within the East Truckee Canyon Citizen Advisory Board Boundary and Washoe County Commission District #4. (APN: 084-282-16).
