Minutes of the regular meeting of the East Truckee Advisory Board held October 16, 2018 at the Stampmill Volunteer Fire Station (400 Stampmill Road, Wadsworth)

1. *CALL TO ORDER/ DETERMINATION OF QUORUM – Ann Owen called the meeting to order at 6:07 p.m.

9.*CHAIRMAN/BOARD MEMBER ITEMS - No items were discussed.

10.*PUBLIC COMMENT –

Jonathan Prichard said the Pyramid Lake Fire Department was awarded a FEMA fire fighting grant to hire additional personal including: 4 paramedics and 3 EMTS which will help expand the services to this area and Pyramid Lake. He said they are adding a community paramedics/community health nurse to help with common cold, blood pressure check; This will help Stampmill neighborhood. Ambulance Saver is still available for the area. He said they have improved their relationship with Storey County. He spoke about the new equipment. He said we have a fire academy of 22 volunteers to help with the services. Jonathan spoke about burning permits for this area – he said they would like to assist with burning of tumble weeds but its TMFPD jurisdiction. Jonathan said seven people should be hired by the end of the month.

Ann Owen spoke about cleaning out the culverts. Said she spoke with a gentleman with the solar representatives; they are waiting for the decision on Prop 3.

Carrie Silas said the County Commissioners will go ahead with Dodge Flat Solar. They are pleased with what has been presented.

Richard Murrieta said he spend a long time to removed weeds. He said the sidewalks are getting bad.
