The parcel is located at 1645 Pine Cone Circle in Incline Village (APN 130-241-62), is 1.25 acres in size, is zoned Low Density Suburban (LDS), and is located within the Tahoe Area Plan. This request is authorized in Article 306, Accessory Uses and Structures, in the Washoe County Development Code, is in Commission District 1, within Section 23, T16N, R18E, MDM, Washoe County, Nevada.
