The Resort-At-Tahoe project is in Crystal Bay, Nevada at the site of the Biltmore Casino. This process is guided by applicable applications, permitting and approvals. Please see below for a status of activity on the site, recent land entitlements and active building permits of interest.

## Site Activity: In April 2022

- Washoe County Community Services Department visited the site on Wednesday, April 8 to review site activity.
- Residents will notice the installation of fencing on the site for the following: to mitigate criminal activity which is unrelated to the project (working with local law enforcement to address activity), to maintain safe construction area, and to support a scheduled fire/sheriff training.
- The site will be used by multiple law enforcement agencies for an upcoming training.

## Washoe County Land Entitlements

• Board of County Commissioners confirmed Board of Adjustment's decision to approve a major grading special use permit for the Resort at Tahoe Project (March 22, 2022).

## Washoe County Building Permits

- As of April 11, 2022, in the morning, no construction is permitted. Building permits are under review.

- construction of approved plans with oversight, concluding with
- affirmation that the constructed project conforms with local, state, and federal mandates as designed and submitted.
