- 5.* **UPDATES/ANNOUNCEMENTS/CORRESPONDENCE** – This item is limited to updates or announcements from CAB members, or review of correspondence received by the CAB.  - A. **Special Use Permit Case No. SB10-010 (Sierra Fire Protection District)** – Review and recommendations on the request to install and operate two 25kW wind turbines at Sierra Fire Protection District Station #36 as authorized in Article 326 of the Washoe County Development Code. The project site is located on the northeast corner of the intersection of ArrowCreek Parkway and Thomas Creek Road. The 3.21 acre parcel is designated Low Density Suburban (LDS) in the Southwest Truckee Meadows Area Plan, and is situated in a portion of Section 24, T18N, R19E, MDM, Washoe County, Nevada. The property is located in the Southwest Truckee Meadows Citizen Advisory Board boundary and Washoe County Commission District No. 2. (APN 049-312-22); Staff Representative: Grace Sannazzaro, Planner, 775.328.3771; Property Owner: Washoe County Department of Public Works; Applicant/Developer: Sierra Fire Protection District, Attn: Captain Mike Greene; Consultant: Smith Design Group.

B.* Washoe County Medical Reserve Corps - Betsy Hambleton, Medical Reserve Corps Program Coordinator, will provide an overview of Washoe County' Medical Reserve Corps (MRC), to include information about the MRC's mission and how the program builds resiliency into communities' disaster/emergency response programs.
