- 8.* **PUBLIC COMMENT** – Comment heard under this item will be limited to items not on the agenda and will also be limited to three minutes per person. Public comment and/or testimony, as applicable, will also be allowed under each individual agenda item and will likewise be subject to the same three minute limitation per speaker. The Chair may modify this time limit for persons and for groups applicable to all public comment and testimony at the beginning of the meeting, but the time limit per person shall be no less than two minutes. Testimony during an agenda item shall be limited to the subject of the agenda item. Comments are to be addressed to the CAB as a whole.
9. **NEW BUSINESS** – (The Staff contact listed on items for Community Development may not be in attendance but can be contacted with code and policy questions.)
 - A. **Regional Transportation Commission (RTC) Presentation regarding "Road Diet" Projects** – An RTC representative will present results and feedback received from recent "road diet" efforts. The CAB will also begin their two-step "road diet" awareness campaign. During the November meeting, the CAB will discuss "road diet" projects including traffic calming on Plateau Road. During the March 2011 meeting, the CAB will discuss "road diet" projects to begin during the summer of 2011.
 - B. ***Hot August Nights Community Report** – Dennis Bryan will make a presentation from the Hot August Nights Board of Directors. Following the presentation, Mr. Bryan will respond to questions from the CAB members and citizens. (This item is for information only and no action will be taken by the CAB.)
10. **OLD BUSINESS** –
 - A. **Continued Discussion & Update of Methods to Raise Public Awareness of the CAB** – The Citizen Advisory Board will provide an update on action taken from the last meeting and will continue to discuss and take possible action on opportunities to raise public awareness of CAB meetings and citizen involvement, including awareness of board openings.
 - B. **Request from Washoe County Public Works for CAB Input for Potential Pedestrian and Bike Projects** – Washoe County is soliciting input from the CABs to develop a list of potential pedestrian and bicycle projects to be located within public right-of-way of County maintained public streets. Washoe County has the opportunity to apply for Transportation Equity Act (TEA) enhancement funds later this year. Projects for this funding source are transportation related and not recreational. As TEA enhancement project funding is limited to \$650,000 per project, a relatively small amount for construction, it is recommended that projects be segmented in sections of ½ mile (2640 feet). In the past, Washoe County has been granted one project on a 2-year funding cycle. Although County staff will not be at the CAB meeting, questions can be directed to Clara Lawson, P.E., P.T.O.E., with Washoe County Public

Works, by emailing her at Clawson@washoecounty.us or calling her at 775.328.3603. Currently, the WTM CAB has previously recommended: traffic calming on Plateau to be added to existing pedestrian and bike path. During the September meeting, the CAB will have an action agenda item on this topic to either recommend: (A) the top three community ranked priority pedestrian and bike path projects or (B) forward all suggested projects for consideration.

11.* CHAIRPERSON/MEMBER COMMENTS – This item is limited to announcements by CAB members of topics/issues posed for future workshops/agendas. The CAB will not discuss matters raised during this item.
