My name is Barbara Fenne and I live in Mogul, Nevada. I am on the Mogul

I am here tonight to learn on your sense of community in helping Mogul to be a safe place to live at all times. I know, with the years our committee has been working with the Riverview Estates Properties LLC developers, safety has not been a leading consideration. Additionally, I believe a person who complains has the

Here are my concerns and recommendations to improve on safety while inevitable construction and development goes on.

responsibility to problem solve those complaints.

- Move the east bound I-80 exit sign east, 15 or more feet so that drivers can see into the west underpass. Add a two-way mirror.
- Add a flashing light in this area to call attention to east bound exit, the east bound entrance, blind underpass and truck turn zone at the juncture of the ungated railroad tracks that are used by residents, fishermen, dog-walkers and recreationalists.

- Re-route development traffic behind the Mogul Storage area that should be paved and the area beautified. This keeps heavy trucks and semis off Mogul Road that has no potential of sidewalks and restricts this road to local residential traffic.
- Extend the westbound I-80 ramp or deny heavy traffic use of this very short ramp.
- If this westbound ramp is extended create a wildlife migration tunnel for the massive and wide range of wildlife coming from the mountains beyond north Somersett.
- Post open recreation sites, trailheads and other historic sites or help to secure the proper signage from these agencies.
- 7. Designate "Lincoln Highway" that runs through the developer's property with a street sign and create or procure proper signage to coordinate with the Scenic Overlook signage nearby on I-80. Move building/s to accommodate and properly site the original road.
- 8. Beautify your area so that views from the Scenic Overlook have a buffer, such as trees, to soften the view so that your buildings do not detract from the beauty of the Truckee River and surrounding areas.

- 9. Add a bike path on Silva Ranch Road between 4th Street and Mogul Mountain Road for the safety of bicyclists on the Tahoe-Reno Bikeway. This would extend from the underpass near Cliffview Drive to Lemming Drive.
- 10. Post or have NDOT post signs: Trucks Entering Area, No Truck Noise and post the hours' trucks can enter Mogul.
- 11. Restrict and post the delivery time for heavy and semi-trucks.
- 12. Widen the turn area and add signage to direct truck traffic to a new truck road parallel to I-80 to keep trucks off Mogul Road. This area is located south of Mogul Storage, at the end of the eastbound I-80 ramp, railroad tracks by east Mogul Road, the Entrance eastbound to Reno and the westbound I-80 underpass close to the Tahoe-Pyramid Bikeway.
