#### **SUMMARY**

Acknowledgement of Publication of Notice of Intent to Augment Budget and approval of the attached resolution to augment the General Fund in the amount of \$3,398,217 for appropriation authority for previously approved but unbudgeted expenditures for the fiscal year 2014-15. Approval of this recommendation will put in place the budget authority for expenditures already approved for fiscal year 2014-15.

Washoe County Strategic Objective supported by this item: Sustainability of our financial, social and natural resources

#### **PREVIOUS ACTION**

5/19/14: Board of County Commissioners (BCC) approved the 2014-15 final budget.

#### **BACKGROUND**

In most years there is a difference between the actual audited ending fund balance of one fiscal year and the budgeted beginning fund balance of the subsequent fiscal year, which is excess beginning fund balance, also known as carryover. It is recommended that a portion of the carryover from fiscal year 2013-2014 available for fiscal year 2014-2015 be used for the following unbudgeted funding requirements:

\$842,587 for the court-restricted capital expansion account project to support the longterm capital needs of the Second Judicial District Court, approved by the BCC on November 13, 2012.

**AGENDA ITEM #** 

**\$69,088** of the carryover will put appropriations in place for the Justice Court Administrative Assessment funds that were transferred to the General Fund in fiscal year 2013-14 but not budgeted for expenditure use in fiscal year 2014-15.

**\$2,486,542** - During the fiscal year 2014-15 budget process, labor agreements were still in the process of being negotiated; therefore, the outcome was not completely included in this fiscal year's budget. Due to vacancies throughout this year many departments have been able to absorb the cost of the labor increases but several departments require additional budget authority. The areas requiring additional budget authority are as follows:

If approved, the augmentation for carryover will result in an increase in appropriations for the General Fund of \$3,398,217, which will be appropriated in the following accounts:
