# **SUMMARY**

The WCSO is requesting award of the quote for the purchase of a grant-funded easyPunch STARlet system for DNA testing for use by the Washoe County Sheriff's Officer Forensic Science Division to Hamilton Robotics, for the net amount of \$76,838.48.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

# PREVIOUS ACTION

# BACKGROUND

The easyPunch STARlet would greatly expedite the DNA analysis of both convicted offender and arrestee samples that are part of the DNA database hit confirmation process. This will allow investigative leads associated with DNA database hits to be promptly reported to the investigating agency.

The easyPunch STARlet is a fully automated integrated punching and liquid handling system. This robot requires minimal human intervention and will allow for the rapid processing of both arrestee and convicted offender samples during the DNA database hit confirmation process.

Two quotes for a fully automated integrated punching and liquid handling system were obtained. The first quote was from Life Technologies that is part of Thermofisher Scientific for



\$188,222.08. Hamilton Robotics provided a quote for a "close out" unit totaling \$76,838.48 which also includes a one year extended warranty. A new instrument from Hamilton Robotics would cost \$155,542 including the one year extended warranty. The Forensic Science Division has performed some testing of this "close out" unit to confirm that it is working as expected. Hamilton Robotics is a local company which will be advantageous for instrument maintenance and repair. Hamilton Robotics will also provide 8 hours of training to the entire DNA section for no additional cost.

Pursuant to NRS 332.146, if the governing body or its authorized representative determines that the supplies, materials or equipment can be purchased at any public auction, closeout sale, bankruptcy sale, sale of merchandise left after an exhibition, or other similar sale at a reasonable savings over the cost of like merchandise and below the market cost in the community, a contract or contracts may be let or the purchase made without complying with the requirements of this chapter for competitive bidding. The documentation for the purchase or acquisition must be summarized for the next regularly scheduled meeting of the governing body, together with written justification showing the savings involved.

# FISCAL IMPACT

Grant 2013-DN-BX-0121 (internal order #11103) will cover \$74,477.57 towards the purchase of the Hamilton easyPunch STARlet robot and Internal Order #20391 (DNA Offender Mandates) will cover the remaining \$2,360.88. FY 14/15 Budget adjustment are needed to increase authority in the Capital Equipment G/L line item by adjusting the following accounts:



### Purchasing Requirements:

In order to meet the needs of State and County tax laws for products and services, it is necessary to place purchase orders with the HAMILTON COMPANY by line item as they appear in the final quotation. By stating each item to be delivered on a purchase order, it alleviates issues with tax on services, matching up packing lists with purchased items, priority partial shipments, invoicing shipped items and 3rd party regulatory and warranty issues.

### 1. General

These general terms and conditions shall apply to all goods supplied by HAMILTON COMPANY to the customer. These general terms and conditions of all goods supplied by HAMILTON COMPANY shall prevail over all other terms and conditions unless the said general terms and conditions have been varied, accepted, and acknowledged subsequently in writing by HAMILTON COMPANY. Any deviation or supplementary conditions or any oral agreements made between HAMILTON COMPANY and the customer especially in relation to the customer's general terms and conditions shall only be applicable if accepted and acknowledged in writing by HAMILTON COMPANY.

### 2. Quotations

Quotations shall only be binding if they contain a stated period of validity and upon approval of credit application per consent from the HAMILTON COMPANY FINANCE DEPARTMENT.

### 3. Scope of delivery

The order acknowledgement is relevant for scope and execution of the delivery. Additional performances or specifications not included in the order acknowledgement are charged separately.

### 4. Technical data and documents

Technical documents such as drawings, descriptions, illustrations and data on dimensions, performance and weight are for information purposes only and shall not imply any warranties. HAMILTON COMPANY reserves the right to make any necessary changes. All technical documentation and technical data remain the property of the HAMILTON COMPANY and may neither be used for production purposes nor be made available to third parties.

### 5. Copyright protection, patent and trademark rights

Trademarks, designs, and projects remain HAMILTON COMPANY' property. Without HAMILTON COMPANY' previous written consent, the reproduction, utilization, or handing over to third parties is prohibited. Particularly, HAMILTON COMPANY equipment must not be made available directly or indirectly (through drawings, diagrams, schematics etc.) to any third party without HAMILTON COMPANY' written authorization.

### 6. Payment Terms:

Payment: Standard payment terms are: Full amount due NET 30 after shipment. Credit approval from the HAMILTON COMPANY FINANCE DEPARTMENT might result in special credit terms. For integrated systems with third party devices, down payments will be required prior to third party equipment purchases as the third party equipment will transfer ownership upon cancellation or order delay by the customer. These terms will be 30% with purchase order, 50% upon shipment NET 10 and 20% NET 30 days after installation and acceptance. A finance charge of 2% per month will be applied for each payment

past due.

### 7. Delivery time

The delivery time of a system will be stated on each quotation and will be dependant upon multiple factors such as current resource workload, 3rd Party item delivery times, custom hardware creation times and custom software application development time. The delivery time starts with the date of HAMILTON COMPANY' order acknowledgement, and ends when the shipment is ready for dispatch or a Site Acceptance Test if required. Compliance with the delivery time is conditional upon the customer fulfilling their contractual obligations, e.g. notification of all essential technical specifications, availability of samples, import permits, down payments, letters of credit etc. Delivery is always subject to prior receipt of an export license granted by Swiss authorities.

The delivery time is reasonably extended if one of the cases applies:

a) The information required by HAMILTON COMPANY for performance of the contract is not received in time, or if the customer subsequently changes the contract thereby causing a delivery delay of the goods. All contract changes require revised Purchase Orders from the customer.

b) Hindrances occur which prevent HAMILTON COMPANY from performing the contract by force majeure. Hindrances include epidemics, mobilization, war, revolution, serious breakdowns in the works, accidents, labor conflicts, late or deficient delivery by subcontractors of raw materials, semi-finished or finished products, official actions or omissions by any state authorities or public bodies, and natural catastrophes.

If the customer claims such damages for delayed delivery, it must be proved that the delay has been caused through HAMILTON COMPANY' fault and that the customer has suffered a loss as a result of such delay. If substitute material can be supplied to accommodate the customer, the latter is not entitled to claim any delay damages. Any delayed delivery does not entitle the customer to any rights and claims other than those expressly stipulated in clause 9. Post installation it is the customer's responsibility to discard the instrument shipping/packing materials.

### 8. Acceptance/Termination

Unless otherwise agreed upon, acceptance shall be affected immediately after installation at the customer's premises. The customer shall inspect the goods within a reasonable period and shall immediately notify HAMILTON ROBOTICS in writing of any deficiencies. If the customer fails to do so, the goods shall be deemed to have been accepted. The result of the acceptance has to be recorded in writing and signed by both parties. The acceptance is fulfilled as soon as the test results prove the specified quality and capacity.

In addition, acceptance shall also be deemed completed when:

• The HAMILTON ROBOTICS has satisfied its standard site acceptance conditions or exceptional conditions agreed upon in writing with the customer prior to acknowledgement of the Purchase Order by the HAMILTON ROBOTICS.

· As soon as the customer uses the goods in a non-acceptance test mode.

If the customer delays acceptance, the outstanding amounts are due 30 days after the originally scheduled acceptance.

### Customer Returned Goods

If a customer decides to return goods, a 20% restocking fee will be charged to the customer with the assumption that the original packaging is intact and used to return the product to the HAMILTON ROBOTICS. If the original packaging is not utilized, the HAMILTON ROBOTICS has the right not to issue credit for the unit until a damage assessment is completed.

No credit will be given returned customized products, third party equipment or other non-recoverable costs such as method development, training, project management, or application support.

### 9. Warranty

The warranty period is 12 months from the installation date. The warranty period either begins on the date of the first day of installation or after acceptance, if site acceptance conditions have been defined and agreed upon in writing by the HAMILTON ROBOTICS and the customer prior to receipt of the system Purchase Order by the HAMILTON ROBOTICS from the



customer. If installation or acceptance is delayed due to reasons beyond the control of the HAMILTON ROBOTICS, the warranty period shall end not later than 18 months after shipment of the goods from the HAMILTON ROBOTICS.

Upon written request from the customer, the HAMILTON ROBOTICS shall quickly repair or replace, at its option, all parts which become defective or unserviceable if determined to be due to bad material, faulty design or poor workmanship. All returned parts which are replaced become the property of the HAMILTON ROBOTICS. The HAMILTON ROBOTICS is responsible only for the cost of repair or replacement of defective parts.

The warranty expressly does not cover consumable parts, damage caused by normal wear, faulty maintenance, failure to observe the operating instructions, and installation not carried out by HAMILTON ROBOTICS as well as due to other reasons for which HAMILTON ROBOTICS is not responsible.

For goods or essential components manufactured by a third party and not authorized by HAMILTON ROBOTICS, there is no warranty.

For goods manufactured by a third party and supplied by HAMILTON ROBOTICS, the warranty is limited to the warranty provided by the third party Supplier.

With respect to any defective material, design, or workmanship as well as any failure to fulfill express warranties, the customer shall not be entitled to any rights and claims other than those expressly stipulated in this clause.

### 10. Exclusion of further liability

All cases of breach of contract and the relevant consequences as well as all rights and claims on the part of the customer are exhaustively covered by these general conditions of supply. In no case whatsoever, shall the customer be entitled to claim damages other than compensation for costs of remedying defects of the goods. This, in particular, refers, but shall not be limited to, loss of production, loss of use, loss of orders, loss of profit, and other direct or indirect or consequential damage.

### 11. Patents

HAMILTON ROBOTICS represents and warrants to Buyer that the manufacture, use or sale of HAMILTON ROBOTICS standard Products do not infringe on any patent, trademark or other intellectual property of any third party. If the standard products sold under the present conditions are produced or modified according to customer's specifications, customer agrees to indemnify and hold HAMILTON ROBOTICS harmless from all lawsuits, judgments, claims, costs and expenses, including but not limited to attorney's and accountant's fees arising in connection with patent infringement.

### 12. License Agreement

The computer software programs remain the property of HAMILTON ROBOTICS. HAMILTON ROBOTICS grants to customer a non-exclusive license to use the proprietary software programs with the equipment specified in the purchase agreement and under the general terms and conditions specified herein.

HAMILTON ROBOTICS may declare parts of the software programs as PUBLIC and which parts will be free of restrictions.

HAMILTON ROBOTICS is not liable for the functionality of third party components.

HAMILTON ROBOTICS is not aware of the rights of any third parties that would oppose the utilization purposes of the licensed software programs. In the event that the software programs infringe on the rights of a third party HAMILTON ROBOTICS will not be liable.

HAMILTON ROBOTICS guarantees the operability of the software programs with the equipment and for the purpose as set forth in the specifications of the purchase agreement under normal conditions of operation and that the software programs have been written following the accepted rules of programming.
