SUMMARY

On July 1, 2015 terms for Michelle Spencer and Sean Shea will expire for the Washoe County Advisory Board to Manage Wildlife. A recommendation to re-appoint both to a second term is scheduled for consideration on June 23, 2015.

PREVIOUS ACTION

March 26, 2014 Mr. John Reed resigned from his position on the Washoe County Advisory Board to Manage Wildlife. The Board appointed Catherine Smith to fill that unexpired term to June 30, 2016.

Mr. Rex Flowers' second term on the Washoe County Advisory Board to Manage Wildlife will expired July 1, 2014. The Board appointed William Gordon "Butch" Tamblyn with term to expire June 30, 2016.

August 27, 2013 - Reappointed Mr. John Reed and appointed Mr. Miles Humphreys Jr. with terms to expire July 1, 2016.

June 26, 2012 - Appointed Mr. Sean Shea and Ms. Michelle Spencer with terms to expire July 1, 2015.

May 24, 2011 - Reappointed Mr. Rex Flowers, with term to expire July 1, 2014.

BACKGROUND

Per Nevada Revised Statutes 501.265 and 501.270, individuals appointed must be citizens of Nevada and bona fide residents of the county from which appointed and be hunters, trappers or anglers or engaged in ranching or farming in the county. Members are appointed upon recommendation of the organized sportsmen and residents of the county. Letters were sent to the various organized sportsmen and residents of Washoe County.

Effective July 1, 2013, per AB168 passed by the Legislature, membership of each county advisory board to manage wildlife to include one qualified member who represents the interest of the general public.
