SUMMARY

Recommendation to award Bid #2947-16 for Janitorial Services for Washoe County High Security Buildings to the lowest responsive and responsible bidder, Qual-Econ U.S.A., Inc, 1015 Telegraph Street, Suite C, Reno NV 89502, for sixteen (16) high security buildings in the amount of \$58,067.00 per month subject to possible price reductions as negotiated by the Contracts Services Supervisor; and authorize the Purchasing and Contracts Manager to execute a two (2) year agreement with one (1) single year renewal option [estimated annual value \$696,804 per year].

PREVIOUS ACTION

On September 11, 2012 the Board awarded Bid No. 2826-13, Janitorial Services for the Washoe County High Security Buildings to Qual-Econ U.S.A., Inc., in the amount of \$50,749.00/per month for sixteen (16) high security buildings for a period of two years, with a single year renewal option, BCC

On September 22, 2009 the Board awarded Bid No. 2675-09, for Janitorial Services for the Washoe County High Security Buildings to Qual-Econ U.S.A., Inc. in the amount of \$54,008.00/per month for seventeen (17) high security buildings for a period of one year with two single year renewal options, BCC 09-992, approved.

On February 20, 2007 - Facility Management presented a side-by-side comparison report of custodial contracts vs. in-house costs for custodial services. As a result of the discussion, the BCC re-authorized the outsourcing of the janitorial services for Washoe County buildings; BCC 07-226, approved.

BACKGROUND

The current janitorial service agreement with Qual-Econ U.S.A. for Washoe County's High Security Buildings expires on 9/30/2015 but will be extended until award of the new agreement. Outsourcing janitorial services has proven successful in providing competitive and satisfactory cleaning services to our buildings since 1999. Since 2001, there have been an increasing number of buildings and programs requiring a higher level of security clearance for custodial contractors. The Community Services Department has determined that having one janitorial service provider for all sixteen (16) of the County's high security buildings increases security, reduces turnover, and improves efficiency for administration of the high security janitorial services contract.

This current recommendation is for a combined award to a single vendor for the purpose of having one contract in place to cut down on the number of different bids and contracts that are brought before the Board and must be administered by Purchasing and the Community Services Department. These facilities include:

- Old Court House
- Liberty Center

- Edison Way Building

Sealed Bids were opened in the Purchasing office at 2:15 p.m., September 2, 2015. The bid was duly advertised in the Reno Gazette-Journal and Demand-Star resulting in the receipt of three (3) bids.

After an analysis and evaluation of the bids by Leticia Harris, Facility Management, Contract Services Supervisor and Mike Sullens, Purchasing and Contracts Manager, it was determined that the lowest responsive and responsible bidder is Qual-Econ U.S.A based on qualifications, local references, proposed staffing, and hours of service. Qual-Econ U.S.A. is the County's current provider for janitorial services of Washoe County's high security buildings and has successfully performed to the County's standards over the previous contract period. Qual-Econ U.S.A. has maintained the one-plus million square feet of high-security space, demonstrating professionalism and responsiveness to the County's needs, including emergencies.

The low bid received from Facility Services Group LLC is deemed to be non-responsive based on their inability to provide <u>local</u> references as required in the bid and taking no exceptions to that requirement. In addition, their proposed hours to complete the work are 17% lower than the current providers and may not be sufficient to meet and maintain the County's cleaning standards. FISCAL IMPACT CONT.

Based on the National Association of Educational Procurement (NAEP) formula for calculating multiple bid savings, this bid process resulted in an approximate eight (8%) savings over the average of the non-awarded bids. Multiple bid savings are calculated by the difference between the awarded bid and the average of the non-awarded bids.

RECOMMENDATION

It is recommended that the Board award Bid #2947-16 for Janitorial Services for Washoe County High Security Buildings to the lowest responsive and responsible bidder, Qual-Econ U.S.A., Inc, 1015 Telegraph Street, Suite C, Reno NV 89502, for sixteen (16) high security buildings in the amount of \$58,067.00 per month subject to possible price reductions as negotiated by the Contracts Services Supervisor; and authorize the Purchasing and Contracts Manager to execute a two (2) year agreement with one (1) single year renewal option [estimated annual value \$696,804 per year].
