SUBJECT:

Recommendation to approve indefinitely the free microchip program for the pets of Washoe County residents. Expenditures for the continued program will be covered under Animal Services budget authority. Continuation of this program will assist in the safe return of animals to their owners and to allow Animal Services to redirect funds to newly created community and educational outreach programs. SUMMARY

The Microchip Campaign to provide free microchips to pets from January 28, 2013 to February 1, 2014 was very successful and Animal Services obtained approval to continue this county-wide program for all Washoe County residents through January 31, 2016.

County priority/goals: Safe, secure and healthy communities.

PREVIOUS ACTION

On November 13, 2012, the Board of County Commissioners (BCC) approved a campaign to waive microchip fees for Washoe County residents starting January 28, 2013.

On February 11, 2014, the BCC approved a continuance of the campaign to waive microchip fees for Washoe County residents for an additional two years.

BACKGROUND

Each year, more than 10 million pets become separated from their owners, costing shelters valuable cage space, time and insurmountable financial resources to care for them. Without identification, many pets are never reunited with their owners.

On January 28, 2013 Animal Services began a year-long Microchip Campaign. The cost for the microchips to start this campaign was \$33,500.00. From January 28, 2013 to October 15, 2015, 13,835 pets were chipped (12,427 dogs and 1,377 cats) at a cost of \$69,175.

During this three-year campaign, 8,228 pets were identified by Animal Services staff to have microchips which facilitated a quick return/notification to their owners which reduced stress on the pet owners and their pets.

The initial impound of an animal by an Officer, including the intake process and first day's housing cost is \$152.28 per animal, with each additional day's housing cost at \$91.26 per animal.

By having the ability to identify owners through the microchip number, Officers have been able to return 3,540 animals in the field and avoid the costly process of impounding an animal. By avoiding the first day's housing cost, Animal Services has recognized an approximate savings value of \$323,060 over the last three years.

When a stray animal has been brought to the shelter by a citizen and the animal has been microchipped, Shelter staff has been able to quickly notify the owners of 4,007 animals. This has recognized an approximate savings value of \$1,097,036 over the last three years.

Animal Services, by quickly identifying animal owners through a microchip, has recognized an approximate total savings value of \$1,420,096 over the last three years.

This proactive and innovative approach to help keep pets safely at home, to reduce operational costs and euthanasia rates, allows Animal Services to redirect funds to our newly created community and educational outreach programs. Washoe County Regional Animal Services recommends continuing the free microchip campaign indefinitely as a valuable resource to the community.

FISCAL IMPACT

Total fiscal impact for Animal Services to purchase supplies as of October 15, 2015 for this three-year free microchip campaign is \$69,175 (which is \$5.00 per microchip).

Annual projected supplies cost to continue the program is \$14,000 to \$17,000, which can be covered within budget authority.

RECOMMENDATION

It is recommended that the Washoe County Board of County Commissioners approve indefinitely the free microchip program for the pets of Washoe County residents. Expenditures for the continued program will be covered under Animal Services budget authority. Continuation of this program will assist in the safe return of animals to their owners and to allow Animal Services to redirect funds to newly created community and educational outreach programs.

POSSIBLE MOTION

Should the Board agree with staff's recommendation, a possible motion would be:

Move to approve indefinitely the free microchip program for the pets of Washoe County residents. Expenditures for the continued program will be covered under Animal Services budget authority. Continuation of this program will assist in the safe return of animals to their owners and to allow Animal Services to redirect funds to newly created community and educational outreach programs.


