

# **Overview of the Department**

Case plans are developed for those who are given a suspended sentence, residential confinement or pre-trial release conditions. Plans may include: reporting to DAS, provisions for job training, drug testing, alcohol testing, counseling, and/or random in-home visits any time without a warrant. Probationers who successfully complete their probation period are deemed to have completed their sentence. Violations, however, can lead to extension of probation period or incarceration.



# **Objectives**


- Create a safer environment for our community and future generations

#### Crossroads


DAS increased collaboration with Crossroads in 2015. This facility provides treatment, housing, and resources. DAS provides staff to immediately address any relapses, assist with the 24/7 program, and provide support to staff. Additionally, court hearings are held at Crossroads once a week.

#### **Tests Administered**




PBT – Preliminary Breath Tests (alcohol)

# Electronic Monitoring vs. Jail



Decreases over the past two years are due to inadequate staffing and out-sourcing.



#### Recidivism

The term recidivism refers to a person's relapse into criminal behavior after successful completion of a court sentence or program.

The USDOJ reports an average of 30 states' recidivism rate is:

30% within 6 months of completion

70% within 5 years of completion

The Department of Alternative Sentencing's Recidivism rate is:

10.17% were arrested since completing in 2015

22.11% were arrested since completing in 2014

32.57% were arrested since completing in 2013

HOWEVER, THIS IS UNSUSTAINABLE WITH INSUFFICIENT STAFFING.

- Creates revenue rather than expense to the county by fee collections and providing an alternative to housing at the county jail.






# **Strategic Plan**
