SUMMARY CONTINUED:

This award recommendation is made on a requirements basis with an estimated annual amount in excess of \$200,000.00 per fiscal year. The term of the award shall be from the date of bid approval through December 31, 2017, with the County retaining the option for a one (1) year extension.

PREVIOUS BOARD ACTION:

No recent board action has been taken on Janitorial Products and Supplies

BACKGROUND:

Hard copy sealed bids and sealed e-bids at www.DemandStar.com were opened in the Washoe County Purchasing Office at 2:15 p.m., Thursday, February 25th, 2016. In accordance with the provisions of NRS 332.039, the Washoe County Purchasing Office solicited bids for Janitorial Products and Supplies.

The Invitation to Bid was duly advertised in the Reno Gazette-Journal and made available through the online services of www.Demandstar.com, resulting in the receipt of seven (7) bids, including two (2) no bid responses, two (2) bids that were disqualified from consideration, and three (3) bids that were received in good order.

In order to be considered as a full line supplier for janitorial products and supplies a bidder needed to bid on a minimum of 90% of the products that were represented on the bid Schedule. Taddy Inc. bid on 78% of the items, Tahoe Supply bid on 89% of the items.

BACKGROUND CONTINUED:

Central Sanitary Supply submitted the lowest, responsive, responsible reply to the Invitation to Bid on the items as stated on the bid schedule, with the dollar value for the represented items totaling \$173,685.47. The bid also states that Washoe County will receive a discount off of their current Pricer/Catalog of 45%. They will also implement a stocking and inventory program for thirty-four (34) different delivery sites for the Community Services Department at no additional charge. In the near future their program will include, real time inventory reports, portable scan capability for replenishment and with drawls, barcode and supply for auto replenishment staying within established mini and max controls and auto download at a remote terminal for transmission to Washoe County.

Brady Industries, LLC 150 East Greg Street, Suite # 106 Sparks, NV 89106

Brady Industries, LLC submitted the second lowest, responsive, responsible reply to the Invitation to Bid on the items as stated on the bid schedule, the dollar value for the represented items is \$184,313.03. The bid also states that Washoe County will receive a discount off of their current Pricer/Catalog of 25%.

Office Depot/Office Max 2990 NorthTowne Reno, NV 89512

Office Depot/ Office Max submitted a bid that was received in good order, with the dollar value for the represented items totaling \$261,212.43.

Janitorial Products and Supplies shall be procured on a requirements basis during the term of the agreement. The agreement period shall run from the date of Bid Award through December 31, 2017, with the County retaining the option for a one (1) year extension of any awards resultant from the Invitation to Bid.

FISCAL IMPACT:

This Award shall be for janitorial products and supplies in the estimated amount of over \$200,000.00 per fiscal year. Since these products are procured on a requirements basis the exact requirements are unknown from year to year.

Funds for the recommended bid award are contained in the Washoe County Sheriff's Office G/L Account # 710300 and Cost Center – 150950, Public Safety & Training G/L Account # 710300 and Cost Center – 209000, CSD – Facility Management G/L Account # 710300 and Order # 20384, 20383 and Cost Center – 105306 and Jan Evan Juvenile Justice Center G/L Account # 710300 and Cost Center – 127500, G/L Account # 710575 and Cost Center 127500. Expenditures have been approved in fiscal year 2015/2016 budget and will be recommended to be approved in fiscal year 16/17, 17/18 and 18/19.
