SUBJECT:	Recommendation to appoint Don Mahin as one of Washoe County's appointees to the Truckee River Fund Advisory Committee. (All Commission Districts.)

SUMMARY

The Truckee River Fund is a 501(c)(3) not-for-profit agency that is operated by the Community Foundation of Western Nevada, funded by Truckee Meadows Water Authority (TMWA) rate payers and established for the sole purpose of funding projects that protect and enhance water quality or water resources of the Truckee River or its watershed.

A nine member Advisory Committee reviews and makes recommendations on project proposals. The cities of Reno and Sparks and Washoe County each appoint three members of the Committee. Members do not serve established terms, but rather "at the pleasure of their respective local governments." One of Washoe County's appointees, Jerry Purdy, has recently resigned. Other Washoe County appointees currently serving are Sue Donaldson (appointed April 2009) and Susan Lynn (appointed in 2014).

Ms. Tracy Turner of the Community Foundation of Western Nevada contacted Washoe County upon the resignation of Mr. Purdy and indicated that a few individuals had expressed interested in serving on the Advisory Committee. Those names along with a list of needed expertise currently lacking on the overall committee was submitted to the Community Services Department who reviewed resumes and vetted candidates for recommendation to the Board of County Commissioners (Board).

Washoe County Strategic Objective supported by this item: Stewardship of Our Community.

PREVIOUS ACTION

On June 17, 2014, The Board of County Commissioners (Board) appointed Susan Lynn to replace John Mosley on the Truckee River Fund Advisory Committee.

April 14, 2009, the Board appointed Sue Donaldson to replace Susan Lynn on the Truckee River Fund Advisory Committee.

On May 16, 2008, the Board appointed John Mosley to replace Daryl Gardipe on the Truckee River Fund Advisory Committee.

On September 14, 2004, the Board appointed Susan Lynn, Arlan Melendez, and Jerry Purdy to the Truckee River Fund Advisory Committee.

BACKGROUND

The Truckee River Fund is a 501(c)(3) not-for-profit agency that is operated by the Community Foundation of Western Nevada, funded by TMWA rate payers and established for the sole purpose of funding projects that protect and enhance water quality or water resources of the Truckee River or its watershed.

General duties of the Advisory Committee are to make recommendations to the TMWA Board and Foundation Board regarding distributions of income and principal from the Fund to potential charitable beneficiaries and any other aspects of the administration of the Fund as considered appropriate by the Advisory Committee.

The Advisory Committee meets at least quarterly to conduct Fund business, reviews and updates the request for proposal and/or reviews project proposals prior to funding meetings and selects potential projects for funding. Projects must be in compliance with the exclusive purposes of the Fund and the Community Foundation's policies and has the responsibility of securing preliminary approval from the TMWA Board, has the responsibility of seeing final approval from the Foundation Board and reviews project reports and reports to the Advisory Committee on the progress of funded projects. The Advisory Committee reviews accountings for the Fund at least annually.

Mr. Mahin has had substantial water and Truckee River experience over his career. His expertise lies with water resources and facility planning, water quality, water rights and water management. Mr. Mahin worked for Washoe County for 25 years preforming a wide variety of water resources planning and management duties involving the Truckee River and groundwater basins in Washoe County and will represent the community well on this advisory committee.

FISCAL IMPACT

There is no fiscal impact associated with Washoe County's making appointments to or participating in the Truckee River Fund Advisory Committee.

RECOMMENDATION

It is recommended the Board of County Commissioners appoint Don Mahin as one of Washoe County's appointees to the Truckee River Fund Advisory Committee.

POSSIBLE MOTION

Should the Board agree with staff's recommendation, a possible motion would be: "Move to appoint Don Mahin as one of Washoe County's appointees to the Truckee River Fund Advisory Committee."

Truckee River Fund – Job Description for Advisory Committee members

The Truckee River Fund, an advised fund at the Community Foundation of Western Nevada, is administered by an advisory committee comprised of nine members, consisting of three members selected by each of the City of Reno, the City of Sparks and Washoe County. None of the members of the Advisory Committee may be elected officials. It is not necessary that the appointee be employed by, or reside in, Reno/Sparks. Current Truckee River Fund advisors may be able to recommend qualified candidates.

Ideal Advisory Committee members:

- have committed to preparing for and attending quarterly advisory meetings and special meetings deemed necessary by the Advisory Committee
- have a background in technical areas not already reflected in the current makeup of the Advisory Committee would be favored
- are very familiar with the Truckee River watershed
- bring technical expertise that helps with evaluation and selection of projects

General Duties of the Advisory Committee

The Advisory Committee makes recommendations to the TMWA Board and the Foundation Board regarding:

- distributions of income and principal from the Fund to potential Charitable Beneficiaries
- any other aspects of the administration of the Fund as considered appropriate by the Advisory Committee.

The Advisory Committee:

- meets at least quarterly to conduct Fund business
- reviews and updates the request for proposal
- reviews project proposals prior to funding meetings
- selects potential projects for funding; projects must be in compliance with the exclusive purposes of the Fund and the Community Foundation's policies
- has the responsibility of securing preliminary approval from the TMWA Board
- has the responsibility of seeing final approval from the Foundation Board
- reviews project reports and reports to the Advisory Committee on the progress of funded projects
- reviews accountings for the Fund at least annually.

Truckee River Water Quality Settlement Agreement

Role Description: Technical and Policy negotiator, representing Reno, Sparks, and Washoe County, of an agreement to settle litigation between the Pyramid Lake Paiute Tribe, the cities of Reno and Sparks, the State of Nevada, the Department of the Interior, and the Environmental Protection Agency relating to the permitting and construction of a wastewater treatment facility owned by Reno and Sparks. Developed management schedules for augmentation of Truckee River flows for water quality enhancement purposes. Acquired water rights and associated real property. Developed and submitted water rights change applications to the state of Nevada. Administered \$12 million fund held by Washoe

County for implementation of the WQSA on behalf of Reno, Sparks, and Washoe County. Provided expert testimony regarding water rights change applications in administrative hearings before the Nevada State Engineer. Coordinated management of water rights with the Pyramid Lake Paiute Tribe and the US Department of the Interior agencies.

Donald A. Mahin P.E., P.G.

Biography

Following completion of his M.S. degree in Hydrology at the University of Nevada, Reno in 1978, Mr. Mahin spent 4 years working for consulting firms in the western United States involved in water resource development and water quality projects in California, Nevada, Utah, Oregon, Washington, Colorado, Wyoming, Indiana, Wisconsin and Alaska. During this time he obtained his Indiana Professional Geologist Certification.

In 1982 Mr. Mahin started work for Washoe County as a Hydrologist for the Regional Administrative Planning Agency (RAPA) initial performing ground water basin studies and reviewing the Water Resource Planning of the Sierra Pacific Power Company. Also in 1982, he obtained his California Professional Engineer registration in Civil Engineering which he followed with his Nevada Professional Engineer registration in 1983. During his 25 year career with Washoe County, Mr. Mahin worked for RAPA, the Planning Department, the County Managers Office and the Department of Water Resources performing a wide variety of functions related to water resources planning, development and management. He was Washoe County's representative for the negotiation of the Truckee River Operating Agreement and the Truckee River Water Quality Settlement Agreement (WQSA). He served Washoe County on numerous committees and boards, including the Storm Water Permit Coordinating Committee and the Local Government Oversight Committee which was established to implement the WQSA.

Following his retirement from Washoe County, he has been associated with Stantec Consultants as a part time employee working on water resource and management projects in Washoe County primarily for the Truckee Meadows Water Authority, City of Reno and Washoe County. Mr. Mahin is a volunteer with Washoe County Amateur Radio Emergency Service (WCARES), which is a volunteer organization that supports the Washoe County Emergency Manager and emergency service agencies. As a volunteer with WCARES, he serves as its Assistant Emergency Coordinator for the National Weather Service.
