SUBJECT: Approve amendments in expense to the FY16 Advancing Conformance with the Voluntary National Retail Food Regulatory Grant Program (VNRFRPS), IO 11088; and if approved direct the Comptroller's Office to make the appropriate budget adjustment (All Commission Districts).

## **SUMMARY**

The Washoe Board of County Commissioners must approve amendments to the adopted fiscal year budget and direct the Finance Department to make the appropriate budget adjustments.

## **PREVIOUS ACTION**

There has been no previous action this fiscal year.

# BACKGROUND

The Washoe County Health District (District) received a Notice of Grant Award from U.S. Department of Health and Human Services, Food and Drug Administration (FDA) in the amount of \$346,500 (\$69,300 per year), for the period September 12, 2012 through June 30, 2017 in support of the VNRFRPS Grant Program, IO 11088.

The program received permission from the FDA to amend the grant to use Intermittent Hourly Health Educators instead of consultants and increase associated expenses. Staff training was also increased to improve skills and knowledge in regards to the FDA Food Codes, Managing Retail Safety, and Special Food Processes. Funding was reduced in Professional Services to allow for the increase in travel and other areas.
