SUBJECT: Approve modification to the Special Offer Amendment to Westlaw

Subscriber Agreement between the County of Washoe (Office of the District Attorney) and West, a Thomson Business [\$155,004] for the period of July 1, 2016 through June 30, 2017, for provision of on-line research capability to the Office of the District Attorney; FY 17 amount \$50,652 --District Attorney. (All Commission Districts.)

SUMMARY

The continuation of the Westlaw subscription between West, a Thomson business, and Washoe County District Attorney's Office will allow the on-line research capability to the Office of the District Attorney.

Strategic Objectives supported by this item: Safe, Secure and Healthy Communities

PREVIOUS ACTION

On July 15, 2008, the Board of County Commissioners renewed the District Attorney's Office agreement for three years. The Washoe County District Attorney's Office has paid for a Westlaw subscription since February 1, 2002. This extension contract will allow for a continuation of the existing subscription.

BACKGROUND

The Washoe County District Attorney's Office currently has Westlaw subscription available to its entire legal staff. Westlaw allows our personnel access to necessary annotated laws, documents, publications, and rulings which would cost prohibitive to purchase separately. This contract will extend the subscription to June 30, 2019.

West will provide on-line access, at the rate of \$4,221 per month which amounts to \$50,652 for fiscal year 2017; the rate of \$4,305 per month which amounts to \$51,660 for fiscal year 2018; the rate of \$4,391 per month which amounts to \$52,692 for fiscal year 2019.

FISCAL IMPACT

FY 17 amount of \$50,652 is budgeted for in the District Attorney's Books and Subscriptions account 710355, Cost Center 106100.

RECOMMENDATION

It is recommended that the Board to approve modification to the Special Offer Amendment to Westlaw Subscriber Agreement between the County of Washoe (Office of the District Attorney) and West, a Thomson Business [\$155,004] for the period of July 1, 2016 through June 30, 2019, for provision of on-line research capability to the Office of the District Attorney.

POSSIBLE MOTION
