- SUBJECT: Possible action to approve an appointment of either Rebecca Kapuler or Scott Carey to the Washoe County HOME Consortium Technical Review Committee (TRC) to fill a term beginning on July 1, 2016, and ending on June 30, 2019. The HOME program is a Federal program to distribute affordable housing funds to local jurisdictions for the purpose of constructing affordable housing. The Washoe County HOME Consortium consists of Washoe County, the City of Sparks and the City of Reno (lead agency). The managers of the three jurisdictions serve as the Consortium Directors and make all funding and policy decisions. The TRC of the HOME Consortium is responsible for developing the application procedures for securing HOME funds, for reviewing those applications, and for making recommendations for funding to the HOME Consortium Directors based on the housing priorities established in each jurisdiction. (All Commission Districts.)

SUMMARY

Ms. Christina Leach, Washoe County's citizen appointee to the Technical Review Committee (TRC) of the Washoe County HOME Consortium, resigned in June of 2014. The Washoe County at-large representative has traditionally been difficult to fill. A three year commitment has caused many potential applicants to be reluctant to apply. After Ms. Leach's resignation, staff began a search for a replacement. After several false starts, staff has identified two qualified applicants, Mr. Scott Carey and Ms. Rebecca Kapuler. Each applicant is a qualified and motivated candidate for the position, and they each demonstrate an interest in affordable housing in the community. Both applicants demonstrate an extensive record of community involvement and participation.

The by-laws of the TRC state that the position is a three year term commencing on July 1st. Therefore, this appointment would begin July 1, 2016 and run through June 30, 2019. The by-laws also state that re-appointment is not necessary at the end of a term, unless the member resigns. If the member states a desire to continue as a member, another three year term is automatically granted.



Washoe County Strategic Objective supported by this item: Stewardship of Our Community.

PREVIOUS ACTION

On February 12, 2013, the Board reappointed Christina Leach to a term as the Washoe County at-large representative on the Washoe County HOME Consortium Technical Review committee. Ms. Leach resigned in June of 2014.

BACKGROUND

The TRC of the HOME Consortium is responsible for developing the application procedures for securing HOME funds, for reviewing those applications, and for making recommendations for funding to the HOME consortium Directors. The Directors consist of the city and county managers of the three HOME Consortium partners – Reno, Sparks, and Washoe County. The TRC consists of one staff member from each jurisdiction and the Truckee Meadows Regional Planning Agency, one member representing a technical specialty (usually drawn from a local financial institution), and one citizen appointee from each jurisdiction.

As noted in the Summary section of this staff report, the citizen appointee position for Washoe County has proven particularly difficult to fill and maintain. After a lengthy search, staff is pleased to have identified two qualified applicants for the Board's consideration: Rebecca Kapuler and Scott Carey. Each applicant demonstrates a motivated interest in the issue of affordable housing, and each has a background that qualifies them to be an effective board member on the TRC. Given two highly qualified applicants, staff does offer some guidance for the Board's consideration. The difficult nature of finding a committed volunteer to stay for a full three year term has adversely impacted the operation of the TRC. While no specific issue or concern has arisen due to the empty seat, it is assumed that a full committee functions at a higher level than one with vacancies. In fact, there is a significant learning curve to understand the complex nature of the HOME Consortium operation. It is particularly valuable to identify individuals who may be committed to two full three year terms. Staff believes such a commitment would result in the highest functioning TRC. Therefore, as the Board considers these two excellent applicants, staff requests the Board consider the ability of the applicants to be committed to at least a full three year term and perhaps a full two terms equaling six years. The by-laws of the HOME consortium require that staff provide a recommendation to the Board. While both candidates are clearly qualified, staff recommends Rebecca Kapuler due to her voluntary attendance at HOME TRC meetings throughout this past application round. Her voluntary attendance has not only demonstrated Rebecca's commitment to learning the process but has put her a bit ahead of the game in that regard.

The Community Service Applications for Rebecca Kapuler and for Scott Carey are included as Attachment A to this staff report.

FISCAL IMPACT

No fiscal impact. Members do not receive a stipend for their services.

RECOMMENDATION

It is recommended that the Board approve the appointment of either Rebecca Kapuler or Scott Carey to the Washoe County HOME Consortium Technical Review Committee to fill a term beginning on July 1, 2016, and ending on June 30, 2019.

POSSIBLE MOTION

Should the Board agree to appoint one of the two applicants to the Washoe County HOME Consortium TRC a possible motion would be: "Move to approve the appointment of [Rebecca Kapuler or Scott Carey] as the Washoe County at-large representative on the Washoe County HOME Consortium Technical Review Committee to fill a term beginning on July 1, 2016, and ending on June 30, 2019."
