June 22, 2010 – Appointed Mr. David J. Stark to the Washoe County Audit Committee for the term commencing July 1, 2010 and expiring on June 30, 2012.

Mr. Stark is highly qualified as he is a practicing Certified Public Accountant. He serves as an Audit Manager with Pangborn and Company, Ltd., where he has been employed over the last 26 years.
