SUMMARY

The Washoe County Sheriff's Office Citizen Corps Program has received a donation in the amount of \$300.00 for their volunteer efforts at Hot August Nights, a community event held August 2 through 7, 2016. This donation will go to support the Citizen Corps Programs (CCP), whose volunteer teams include the Community Emergency Response Team (CERT), Sheriff's Mobile Auxiliary Response Team (SMART), Citizen's Homeland Security Council (CHSC) / Terrorism Liaison Officer Volunteer (TLOV) program and the new Rail Auxiliary Team.

These funds are intended to be used to support the CCP teams, including but not limited to the purchase of equipment, supplies, food and beverage to be used in emergency response, training, drills, support events or rehab during disasters, and items that can be sold to the volunteers to raise additional funds to support the Citizen Corps Programs.
