#### **SUMMARY**

The Sparks Police Department received an award in the amount of \$38,305.00. They allocated a portion of this funding to cover our overtime costs associated with the implementation of their project. This funding covered overtime costs for deputies that worked with the Regional Sex Offender Task Force while engaged in task force activities involving the Adam Walsh Compliance project.

#### PREVIOUS ACTION

The Board previously approved JAG Sparks Police Department funding for the Regional Gang Task Force on 1/12/16.

#### BACKGROUND

They provide part of that funding to our agency to cover overtime costs associated with work on the task force. Title 8, United States Code, Section 1373 (Section 1373) addresses the exchange of information regarding citizenship and immigration status among federal, state, and local government entities and officials. Subsection (a) prevents federal, state and local government entities and officials from "prohibit[ing] or in any way restrict[ing]" government officials or entities from sending to, or receiving from, federal immigration officers information concerning an individual's citizenship or immigration status. Subsection (b) provides that no person or agency may "prohibit, or in any way restrict," a federal, state, or local government entity from (1) sending to, or requesting or receiving from, federal immigration officers information regarding an individual's immigration status, (2) maintaining such information, or (3) exchanging such information with any other federal, state, or local government entity. Section 1373 does not impose on states and localities the affirmative obligation to collect information from private individuals regarding their immigration status, nor does it require that states and localities take specific actions upon obtaining such information. Rather, the statute prohibits government entities and officials from taking action to prohibit or in any way restrict the maintenance or intergovernmental exchange of such information, including through written or unwritten policies or practices.

Your personnel must be informed that notwithstanding any state or local policies to the contrary, federal law does not allow any government entity or official to prohibit the sending or receiving of information about an individual's citizenship or immigration status with any federal, state or local government entity and officials.

Please note: A grantee is required to assure and certify compliance with all applicable federal statues, including Section 1373, as well as all applicable federal regulations, policies, guidelines and requirements. This requirement passes through to any subgrants that may be made and to any subrecipients that receive federal funds.
