SUMMARY

It is requested that the Board of County Commissioners (BCC) authorize acceptance of \$23,226.00 in donations from the Lifestyle Homes Foundation. The Lifestyle Homes Foundation gave a cash donation in the amount \$23,226.00 to the Washoe County Sheriff's Office, Patrol Division to be used to purchase rifles, optics and related equipment for the Motor Unit.

BACKGROUND

The Motor Unit's primary functions are to conduct traffic enforcement and investigate traffic accidents. The unit also participates in dignitary protection, parade escorts, funeral escorts, honor guard detail and special events. Due to the limited space available on a motorcycle, the motorcycles have not had rifles. The Lifestyle Homes Foundation donation will provide a compact rifle, accessories and specialized mount to equip each motorcycle with a rifle.
