GENERAL ELECTION STATISTICS

■ **269,018 Registered Voters**

All time record in Washoe County for number of registered voters

- Democratic – 94,520
- Republican – 99,675
- Nonpartisans – 56,408
- Minor parties and Other – 18,415
- **TOTAL = 269,018**

ELECTION INFORMATION


- 23 Early Voting locations with addition of Sun Valley Neighborhood Center

TURNOUT AFTER FIRST WEEKEND OF EARLY VOTE (EARLY VOTE AND ABSENTEE COMBINED)


- **TOTAL TURNOUT – 14,666**
 -  **Democratic – 6,556**
 -  **Republican – 5,669**
 - **Minor Party and Nonpartisans – 2,441**
- **First two days 2016 General = 15,010**
- **First two days 2014 General = 5,642**

SAMPLE BALLOTS

- **Mailed in Two Parts**
 - Informational portion with ballot facsimile
 - 2018 Ballot Questions
- **Two Reasons**
 - Size of the sample ballot is large with the length of ballot questions
 - Cost savings to mail two pieces separately
 - Savings on cost of labor on manual insertions of an additional piece and postage savings

ELECTION MAILERS

What Voters Should Know:

- Can come from Political Parties, Nonpartisan Organizations, or other Third Party Groups
- These groups and these type of mailings are not coordinated by or affiliated with our office or the office of the Secretary of State
- Their mailing lists are also not coordinated with our office and can come from mail house lists or other sources
- By law, they must identify who the sender is and they cannot have any logo/seal of a State or local government agency or official election mail insignia

VOTER REGISTRATION AND ADDRESS CORRECTIONS

- **Voter registration and address updates and corrections are a continuous part of what we do**
- **We perform several voter list maintenance projects each year along with notifications from the USPS or other sources; however, not everyone gets caught in these nets**
- **What to do if you receive election related mail at your address for someone who is not a resident of your address**
- **Voters can register without having a physical address assigned to you where you reside**

SECURITY UPDATE

- Working with Department of Homeland Security (DHS) and the Secretary of States Office
 - Albert sensor installed to monitor traffic and reports questionable activity across the network
 - Participated in the National Table Top Exercise at the State Emergency Operations Center in conjunction with DHS in August in preparation for the General Election
- **EI-ISAC (Elections Infrastructure Information Sharing & Analysis Center)**
- **MS-ISAC (Multi-State Information Sharing & Analysis Center)**
 - As a member we have access to election-specific threat intelligence products, cybersecurity awareness and training products and webinars, security best practices, and cybersecurity alerts and advisories.
