Good Morning

The team had been tasked with finding a vendor that would provide test kits and testing. We have been working on best solution for over a week that meets FDA requirements. The original solution was a 100,000 tests with lab which equated to 2.7 million dollars. That option fell through and now the only FDA approved option that is specific to COVID 19 that we have been able to find is the above request. Earlier this week I spoke with the Agency Administrators who all agreed to a number of 5000 kits. I had requested 25,000 kits from the Agency Administrators. They chose based on information to down size that order to 5,000 kits. These kits are FDA approved and go to an independent lab for results which will not overload the state lab that we will also continue to use. Hope this clears things up if not let me know. Thanks
