ORDINANCE VALLEY QUAIL.

On motion duly seconded and carried by the unanimous vote of the board, it was ordered that the following ordinance be adopted and published in the Nevada State Journal for two issues, to-wit:

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1. It shall be unlawful to kill, catch, trap, wound, or pursue with intent to catch, capture, injure, or destroy, any valley quail at any time during the year other than during an eleven-day period to be known as the open season, beginning November 20th. of each and every year and ending November 31st. of each and every year, which said period of time, to-wit, from November 20th. to November 30th., is hereby designated by the Board of County Commissioners of Washoe County, Nevada, as the open season for valley quail.

SEC. 2. The County Clerk and Clerk of the Board of County Commissioners of Washoe County, Nevada, is hereby authorized and directed to have this ordinance published twice in the Nevada State Journal, a daily newspaper of general circulation in Washoe County, Nevada, and said officer is further directed to spread this ordinance upon the Minutes of the Board of County Commissioners.

SEC. 3. The said County Clerk and Clerk of the Board of County Commissioners of Washoe County, Nevada, is hereby further authorized and directed to notify the Fish and Game Commission, immediately upon the passing of this ordinance, of the action taken by said Board of County commissioners.
