Said closed season for said portion of the Truckee River from Vista, Washee County, Nevada, five miles east as provided in Section 1 hereof, is hereby declared, in the opinion of the said Board of County Commissioners of Washoe County, Nevada, to be required for the protection of the fish in said Truckee River from Vista, five miles east, to the end that the supply of fish for food may be permanently increased, said Truckee River from Vista, five miles east, having been stocked with food fish by the State of Nevada and its Fish Commissioners.
- SEC. 3. This ordinance shall be effective from and after its passage and publication once a week for two (2) consecutive weeks.
- SEC. 4. Any person who shall violate the provisions of this ordinance shall be guilty of a misdemeanor, and shall beffined not less than fifty (\$50.00) dollars nor more than two hundred and fifty (\$250.00) dollars, or imprisoned in the county jail not less than twenty-five (\$25) days nor more than one hundred and twenty-five (\$25) days, or by both such fine and imprisonment, in the discretion of the Court.

# SPECIAL ORDINANCE.

AN ORDINANCE EXTENDING THE CLOSED SEASON FOR FISHING IN THE GALENA, THOMAS AND WHITE CREEKS ON THE EAST SIDE OF MOUNT ROSE DISTRICT, WASHOE COUNTY, NEVADA.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, NEVADA, DO ORDAIN:

- SECTION 1. The closed season for fishing in the Galena, Thomas and White's Creek on the East side of Mount Rose District will be from the 19th day of May to the first day of August, 1932, and from September 15th, 1932, to and including April 15th, 1933.
- SEC. 2. Said closed season for said portion of the Galena, Thomas and White Creeks as provided in Section 1 hereof, is herby declared in the opinion of the said Board of County Commissioners of Washoe County, Nevada, to be required for the protection of the fish in said Galena, Thomas and White Creeks, to the end that the supply of fish for food may be permanently increased, said Galena, Thomas and White Creeks having been stocked with food fish by the State of Nevada and its Fish Commissioners.
- SEC. 3. This ordinance shall be effective from and after its passage and publication once a week for two (2) consecutive weeks.
- SEC. 4. Any person who shall violate the provisions of this ordinance shall be guilty of a misdemeanor, and shall be fined not less than fifty (\$50.00) dollars nor more than two
