Any person who shall violate the provisions of this ordinance shall be guilty of a misdemeanor, and shall beffined not less than fifty (\$50.00) dollars nor more than two hundred and fifty (\$250.00) dollars, or imprisoned in the county jail not less than twenty-five (\$25) days nor more than one hundred and twenty-five (\$25) days, or by both such fine and imprisonment, in the discretion of the Court.

The County Clerk and Clerk of the Board of County Commissioners of Washoe County Nevada, is hereby authorized and directed to have this ordinance published once a week for two (2) consecutive weeks in the Nevada State Journal, a newspaper published and of general circulation in Washoe County, Nevada, and to also post a copy of this ordinance in at least fourt (4) conspicuous places along the side of the Truckee River from Vista, five miles east, in Washoe County, Nevada.
