COUNTY ORDINANCE NO. 1

AN ORDINANCE ESTABLISHING THE UNINCORPORATED AREA OF WASHOE COUNTY AS A RESTRICTED AREA; PROVIDING CERTAIN RULES AND REGULATIONS RELATING TO THE USE OF LAND, BUILDINGS AND IMPROVEMENTS WITHIN SAID DISTRICT; PRESCRIBING A PENALTY FOR THE VIOLATION THEREOF; AND OTHER MATTERS RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. In order to meet the present emergency relating to Zoning and Land Use, to promote and protect the public peace, health, safety, comfort, convenience, and the general welfare of the people of Washoe County, all of the unincorporated area of Washoe County is established as, and is declared to be, a restricted area.

Section 2. It is hereby declared that in the creation of this restricted area, the County Commissioners have given due consideration to the necessity for the creation of zones which will regulate the uses of land, area requirements, density of land occupancy, and the necessary, proper, and comprehensive groupings and arrangements of the various industries, businesses, homes and population of the unincorporated area of Washoe County in accordance with a well considered Master Plan of Land Use for the development of the entire county.

Section 3. It is hereby further declared that the progressive adoption by ordinances of zoning plans in conformance with the Master Plan of Land Use placing various portions of such unincorporated area in the respective zones applicable thereto as soon as due and careful consideration by the Washoe County Planning Commission, and by the Washoe County Board of Commissioners, will permit, is intended to result eventually in a comprehensive and well considered plan of location and distribution of the various industries, businesses, homes and population of the entire

unincorporate area of Washoe County and in relation to future plans for the incorporated area of said county.

Section 4. All departments, officials, or public employees vested with the duty or authority to issue permits or licenses where required by law, shall conform to the provisions of this ordinance. No license or permit for the use of buildings, where the purpose would be in conflict with the provisions of this ordinance shall be issued. Any such license or permit issued in conflict with the provisions of this ordinance shall be null and void.

Section 5. Any person, firm, or corporation desiring to erect, construct, convert, alter, enlarge, or use any building or improvement or use any lot, parcel of land, or premises within the restricted area shall make a written declaration of the intended use or occupancy of said building, improvement or premises, on forms supplied for that purpose in the office of the County Clerk of Washoe County, and such use or occupancy shall not be altered or converted to another use or occupancy until a new declaration of occupancy shall be made.

Section 6. No person shall erect, construct, convert, alter enlarge, or use, any building or improvement, or use any lot, parcel of land, or premises in the restricted area for any purpose except as hereinafter specifically provided:

A. Any lot, parcel of land, premises or building in the restricted area may be used and occupied for the following purposes: Single and multiple family dwellings, apartment houses, boarding and rooming houses, churches, schools, parks, playgrounds, libraries, or professional occupations when conducted within the dwelling or apartment and in which no person not a resident of the premises is employed.

1 B. Any lot, parcel of land, premises, or building in the 2 restricted area may be used for any business, occupation, or pur-3 pose which is not required by any other ordinance of Washoe 4 County to secure a license or permit from any department or official of said county; provided, that in the opinion of the Washoe 5 County Planning Commission such business, occupation, or purpose 7 will not be detrimental to the particular community in which said use is to be located. 8 Section 7. This ordinance does not prohibit a continuation 9 10 of the particular existing uses of any building, structure, im-11 provement or premises existing at the time this ordinance or any 12 amendment thereto becomes effective if such existing use is not in violation of any other ordinance or law. 13 14 Section 8. Penalties. Any person, firm or sorporation vio-15 lating any of the provisions of this ordinance, or of any permit or exception granted hereunder, shall be deemed guilty of a mis-16 demeanor, and upon conviction thereof, shall be punishable by a 17 18 fine of not to exceed Five Hundred Dollars (\$500.00) or by imprisonment in the County Jail for not to exceed six (6) months, 19 20 or by both such fine and imprisonment, Each separate day or any 21 portion therof during which any violation of the ordinance occurs 22 or continues shall be deemed to constitute a separate offense and 23 upon conviction therefore shall be punishable as herein provided. 24 Section 9. This ordinance shall be in effect from and after 25 its passage and approval.
