ORDINANCE NO. ___1

AN ORDINANCE AMENDING COUNTY ORDINANCE NO. 1 TO PROVIDE A SUMMARY AND REVISED TITLE THEREOF; TO AMEND THE LAW LIBRARY FUND TO PROVIDE FEES TO BE SET ASIDE IN THE SUM OF \$4 BY THE WASHOE COUNTY CLERK AND TO REVISE SECTION 4 TO PROVIDE FOR AN EFFECTIVE DATE OF THE ORDINANCE.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. There is hereby added to County Ordinance No. 1 a Summary of said Ordinance to read as follows:

An ordinance adopting the provisions of state law for the establishment, maintenance and operation of law libraries, setting fees to be set aside on the commencement in, or removal to, the District Court of Washoe County of any civil action, proceeding or appeal, and authorizing the Board of Trustees of said Law Library to do all things necessary to establish and maintain said Library.

Section 2. The Title of County Ordinance No. 1 is hereby amended to read as follows:

AN ORDINANCE ADOPTING THE PROVISIONS OF STATE LAW FOR THE ESTABLISHMENT, MAINTENANCE AND OPERATION OF LAW LIBRARIES, SETTING FEES TO BE SET ASIDE ON THE COMMENCEMENT IN, OR REMOVAL TO, THE DISTRICT COURT OF WASHOE COUNTY OF ANY CIVIL ACTION, PROCEEDING OR APPEAL, AND AUTHORIZING THE BOARD OF TRUSTEES OF SAID LAW LIBRARY TO DO ALL THINGS NECESSARY TO ESTABLISH AND MAINTAIN SAID LIBRARY, AND OTHER MATTERS PROPERLY PERTAINING THERETO.

Section 3. Section 2 of County Ordinance No. 1 is hereby amended to read as follows:

Section 2. Law Library Fund: Fees set aside.
On the commencement in, or removal to, the District
Court of Washoe County of any civil action, proceeding or appeal, on filing the first papers
therein, the clerk of the court shall set aside
from the costs received the sum of \$4 in each case
for a fund which shall be and is hereby designated
as the "Law Library Fund" to be expended in the

establishment and maintenance of a law library in the county seat of the county, which law library shall be governed and controlled as provided for in the act of the Legislature of the State of Nevada.

Section 4. Section 4 of County Ordinance No. 1 is hereby amended to read as follows:

Section 4. This Ordinance shall be in full force and effect from and after its passage and approval.

Section 5. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
