ORDINANCE NO. 2

AN ORDINANCE TO SECURE THE PROPER CONTROL, MANAGEMENT AND DIGNITY IN AND ABOUT THE WASHOE COUNTY COURT HOUSE; PROHIBITING ANY FORM OF SOLICITATION IN AND ABOUT SAID COURT HOUSE; PROVIDING A PENALTY FOR THE VIOLATION THEREOF AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Soliciting about court house unlawful. It shall be unlawful for any person to solicit anyone for any goods, merchandise or any other purpose whatsoever in and about the Washoe County Court House.

Section 2. Penalty. Any person who shall violate the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in the sum of not more than \$500, or imprisoned in the County Jail for a term not to exceed 6 months, or punished by both fine and imprisonment.

ORDINANCE NO. 3

AN ORDINANCE TO SECURE THE PROPER CONTROL, MANAGEMENT AND DIGNITY OF PROPERTY OWNED, OCCUPIED, CONTROLLED OR MANAGED BY WASHOE COUNTY; PROHIBITING THE STEERING AND INFLUENCING OF PERSONS WHO INTEND TO BE MARRIED IN WASHOE COUNTY; PROVIDING A PENALTY FOR THE VIOLATION THEREOF AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Steering persons for marriage ceremonies unlawful. It shall be unlawful for any person to solicit, influence, guide, steer, procure, entice, decoy or otherwise induce or lead any person or persons who are on or within any property owned, occupied or otherwise controlled or managed by the County of Washoe, to a judge, justice of the peace, minister, rabbi or priest for the purpose of the judge, justice of the peace, minister, rabbi or priest officiating at a marriage ceremony of such person or persons.

Section 2. Penalty. Any person who shall violate the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in the sum of not more than \$500, or imprisoned in the County Jail for a term not to exceed 6 months, or punished by both fine and imprisonment.
