ORDINANCE COVERING SOLICITING IN THE COURT HOUSE

It was ordered that the following Ordinance be adopted and spread in full upon the Minutes:

ORDINANCE No. \_\_\_\_\_

AN ORDINANCE TO SECURE THE PROPER CONTROL, MANAGEMENT AND DIGNITY OF PROPERTY OWNED, OCCUPIED, CONTROLLED OR MANAGED BY WASHOE COUNTY; PROHIBITING THE STEERING AND INFLUENCING OF PERSONS WHO INTEND TO BE MARRIED IN WASHOE COUNTY; PROVIDING A PENALTY FOR THE VIOLATION THEREOF AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1.

It shall be unlawful for any person to solicit, influence, guide, steer, procure, entice, decoy or otherwise induce or lead any person or persons who are on or within any property owned, occupied or otherwise controlled or managed by the County of Washoe, to a Judge, Justice of the Peace, Minister, Rabbi or Priest for the purpose of said Judge, Justice of the Peace, Minister, Rabbi or Priest officiating at a marriage ceremony of such person or persons.

Section 2:

Any person who shall violate the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction/therof shall be fined in the sum of not more than Five Hundred (\$500.00) Dollars or by imprisonment in the County Jail for a term not to exceed six (6) months, or by both such fine and imprisonment.

Section 3:

This ordinance shall be in full force and effect from and after its passage and approval.
