## ORDINANCE NO. 11

AN ORDINANCE TO PROHIBIT THE POSSESSION, SALE, STORAGE OR HANDLING OF ROCKETS, SQUIBS, FIRE CRACKERS, ROMAN CANDLES OR OTHER FIREWORKS OR BLANK CARTRIDGES, AT ALL PLACES OUTSIDE OF THE LIMITS OF INCORPORATED CITIES AND TOWNS WITHIN THE COUNTY OF WASHOE, STATE OF NEVADA.

## THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Possession of fireworks unlawful. It shall be unlawful for any person, firm, association or corporation to have in their possession, or under their control, for sale or otherwise, or to store or otherwise handle within the County of Washoe, State of Nevada, outside of the limits of incorporated cities and towns, within said County of Washoe, any rockets, squibs, firecrackers, roman candles or any fireworks of any description whatsoever, or any blank cartridges for what is known as cap pistols.

Section 2. <u>Penalty</u>. Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and on conviction thereof shall be punished by a fine of not more than \$500, or by imprisonment in the County Jail of Washoe County, Nevada, not to exceed 6 months.

Section 3. Effective date. This ordinance shall be in effect on and after the 1st day of September, 1935, and the County Clerk of Washoe County, as Ex officio Clerk of the Board of County Commissioners is hereby authorized and ordered forthwith to cause this ordinance to be published in the Nevada State Journal for a period of 1 week.

## FIRE CRACKER ORDINANCE

On motion duly seconded and carried by the unanimous vote of the board, it was ordered that the following ordinance be adopted:

ORDINANCE NO. 204

AN ORDINANCE TO PROHIBIT THE POSSESSION, SALE, STORAGE OR HANDLING OF ROCKETS, SQUIBS, FIRE CRACKERS, ROMAN CANDLES OR OTHER FIRE-WORKS OR BLANK CARTRIDGES, AT ALL PLACES OUTSIDE OF THE LIMITS OF INCORPORATED CITIES AND TOWNS WITHIN THE COUNTY OF WASHOE, STATE OF NEVADA.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE, STATE OF NEVADA, DOES ORDAIN: Section: It shall be unlawful for any person, firm, association or corporation to have in their possession, or under their control, for sale or otherwise, or to store or otherwise handle within the County of Washoe, State of Nevada, outside of the limits of incorporated cities and towns, within said County of Washoe, any rockets, squibs, fire-crackers, roman candles or any fire-works of any description whatsoever, or any blank cartridges for what is known as cap-pistols.

Section 2. Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and on conviction thereof shall be punished by a fine of not more than

Five Hundred (\$500.00) Dollars, or by imprisonment in the County Jail of Washoe County, Nevada, not to exceed six months.

Section 3. This Ordinance shall be in effect on and after the 1st day of September, 1935, and the County Clerk of Washoe County, as Ex-Officio Clerk of the Board of County Commissioners is hereby authorized and ordered forthwith to cause this Ordinance to be published in the Nevada State Journal for a period of one week.
