ORDINANCE NO. 43

AN ORDINANCE ADOPTING THE REVISED ORDINANCES OF WASHOE COUNTY, STATE OF NEVADA; RENUMBERING CERTAIN ORDINANCES HERETOFORE ENACTED; REPEALING CERTAIN ORDINANCES, ORDERS AND RESOLUTIONS HERETOFORE ENACTED AND ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, NEVADA; AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

- Section 1. Adoption of revised county ordinances. The revised county ordinances of Washoe County, State of Nevada, as heretofore revised, compiled and printed pursuant to the order of the Board of County Commissioners of Washoe County, Nevada, are hereby adopted.
- Section 2. Catchlines of sections. The catchlines of the several sections of the revised county ordinances are intended as mere catchwords to indicate the contents of the section, and unless otherwise necessary, shall not be deemed or taken to be titles of such sections, nor as any part of the section.
- Section 3. Numbering and renumbering of previously enacted ordinances.

That certain unnumbered ordinance entitled "An ordinance creating a planning commission for the County of Washoe, authorizing the formation of a regional planning district with the cities of Sparks and Reno or either of them; providing for the appointment of representatives from said Washoe County Planning Commission to a regional planning commission, and other matters properly related thereto," enacted by the Board of County Commissioners of Washoe County on February 21, 1944, and recorded in Book "P" of the Proceedings of the County Commissioners at page 251, is hereby repealed.
- 18. That certain ordinance numbered Ordinance No. 1 entitled "An ordinance establishing the unincorporated area of Washoe County as a restricted area; providing certain rules and regulations relating to the use of land, buildings and improvements within said district; prescribing a penalty for the violation thereof; and other matters relating thereto," enacted by the Board of County Commissioners of Washoe County on August 8, 1945, and recorded in Book "P" of the Proceedings of the County Commissioners at page 464, is hereby repealed.
- 19. That certain ordinance numbered Ordinance No. Two entitled "An ordinance regulating the establishing, operating, maintaining and advertising of child care facilities; providing for the issuance of licenses and the collection of fees therefor; and providing penalties for the violation thereof." enacted by the Board of County Commissioners of Washoe County on September 5, 1945, and recorded in Book "P" of the Proceedings of the County Commissioners at page 480 is hereby repealed.
- 20. That certain ordinance numbered Ordinance No. 8 entitled "An ordinance requiring building permits; prescribing a penalty for the violation thereof, and other matters relating thereto." enacted by the Board of County Commissioners of Washoe County on April 20. 1946, and recorded in Book "Q" of the Proceedings of the County Commissioners at page 20, is hereby repealed.
- 21. That certain ordinance numbered Ordinance No. 24 entitled "An ordinance to secure the proper control and management of property owned, occupied, controlled and managed by Washoe County; prohibiting the soliciting of persons who intend to be married on property owned, occupied or controlled by Washoe County, Nevada; providing a penalty for the violation thereof and other matters properly relating thereto," enacted by the Board of County Commissioners of Washoe County on May 5, 1950, and recorded in Book "R" of the Proceedings of the County Commissioners at page 169, is hereby repealed.
- Section 5. Effective date. In accordance with the provisions of section 2 of chapter 296, Statutes of Nevada 1955, this ordinance shall become effective upon the publication in book form of the Revised Ordinances of Washoe County, such revision having heretofor been authorized and ordered by the Board of County Commissioners.
