In accordance with Chapter 296 of
the 1955 statutes of the State of Ne-
vada, NOTICE is hereby given that an
ORDINANCE TO ESTABLISH A SPEED
LIMIT ON THAT PORTION OF 12TH
STREET IN SECTION 5, T 19N R. 20E,
LYING IN ARDMORE PARK, WASHOE
COUNTY, NEVADA, SITUATED BE-
TWEEN THE CITY LIMITS OF
SPARKS, NEVADA, AND EXTENDING
FROM THE NORTH TRUCKEE DITCH
NORTHERLY TO THE PEOPLES
DRAIN DITCH, PROVIDING THE
PENALTY FOR VIOLATION THERE-
OF, AND OTHER MATTERS PROP-
ERLY RELATING THERETO, was
proposed on October 20th, 1955 by Com-
missioner Ray Peterson; final action
of adoption taken on November 5th,

6 AN ORDINANCE ESTABLISHING A SPEED LIMIT
7 ON THAT PORTION OF 12TH STREET IN SECTION
8 5, T.19N., R.20E., LYING IN ARDMORE PARK,
9 WASHOE COUNTY, NEVADA, SITUATED BETWEEN
10 THE CITY LIMITS OF SPARKS, NEVADA, AND
11 EXTENDING FROM THE NORTH TRUCKEE DITCH
12 NORTHERLY TO THE PEOPLES DRAIN DITCH;
13 PROVIDING THE PENALTY FOR VIOLATION THEREOF;
14 AND OTHER MATTERS PROPERLY RELATING THERETO.

15 THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE
16 DO ORDAIN:

17 SECTION 1: That on that portion of 12th Street in Section 5,
18 T.19N., R.20E., lying in Ardmore Park, Washoe County, Nevada,
19 situated between the city limits of Sparks, Nevada, and extend-
20 ing from the North Truckee Ditch northerly to the Peoples
21 Drain Ditch, the maximum speed limit for all motor vehicles is
22 hereby established at fifteen (15) miles per hour.

23 SECTION 2: Any person who drives, propels, operates or conducts
24 any motor vehicle on said portion of 12th Street within said
25 area at a rate of speed exceeding fifteen (15) miles per hour
26 shall be guilty of a misdemeanor and shall be punished by a
27 fine not exceeding Five Hundred (\$500.00) Dollars or imprison-
28 ment in the County Jail in Washoe County, Nevada, not exceed-
29 ing six (6) months or by both such fine and imprisonment.

30 SECTION 3: This ordinance shall be in effect from and after
31 its passage and approval.
