## BILL NO. 6

## ORDINANCE NO. 48

AN ORDINANCE REQUIRING BUILDING PERMITS AND THE COLLECTION OF FEES THEREFOR; PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH; AND OTHER MATTERS RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Definitions. "Person" as used in this ordinance shall include a firm, corporation, municipal corporation, association, club, business trust, estate or any group or combination acting as a unit as well as a natural person.

SECTION 2. Building Permit required. It shall be unlawful for any person to erect, construct, enlarge, alter, repair, move, improve, convert or demolish any building or structure within the County of Washoe, which same structure is used, designed or intended for any non-habitable use or occupancy without first obtaining a separate building permit for each such building or structure from the Building Department of Washoe County. For the purposes of this ordinance, the term "habitable" use or occupancy shall refer to private residential uses or occupancys only.

SECTION 3. Form of application. The application for such building permit shall be made in duplicate and on a form supplied by the Building Inspector and shall contain all such information as is necessary to insure the intent, nature and location of the proposed structure as well as whatever other pertinent information as may be required. Such application shall be signed by the applicant or his agent, stating his approval of such application

and attesting to its accuracy and shall contain a statement as to the proposed valuation of the contemplated structure. SECTION 4. Fees, penalties and stop work orders. 1. The applicant or applicants shall at the time of filing an application for a building permit pay to the County of Washoe 5 a fee based upon the following valuations: 6 Less than \$50.00-----no fee. 7 \$50 to \$100-----\$1.00 . 8 \$101 to \$400-----\$2.00 9 \$401 to \$700-----\$3.00 10 \$701 to \$1000----\$4.00 11 each additional \$1,000 or fraction to 12 \$15,000----\$2.00 13 each additional \$1,000 or fraction 14 to \$40,000-----\$1.00 15 each additional \$1,000 or fraction 16 over \$40,000-----\$0.50 17 In the event that no contract fee is stipulated in the application 18 for permit, the following table shall be used in determining the 19 20 valuation and fees applicable: Industrial and commercial buildings; 21 Concrete and steel----- 7.00/sqft. 22 Wood and masonry----\$ 6.00/sqft. 23 24 25 Hotels, motels, 26 Concrete or steel-----\$12.50/sqft. 27 Wood frame siding----- 7.50/sqft. 28

Wood and mascnry-----\$11.00/sqft.

building permit shall fail to obtain same and shall fail or refuse to pay fees as herein set forth, that person or persons shall
be liable for three (3) times the amount of the fee or fees as
penalty and such person shall not be permitted to proceed with the
erection, construction, etc. of any building within the County or
cause the same to be done without first obtaining the required
building permit and paying three times the amount of the fee or
fees to Washoe County.

3. Whenever any building or work is being done centrary to the provisions of this ordinance, the Building Inspector may order the work stepped by notice in writing served on any persons engaged in doing or causing the work to be done, and any such person shall forthwith stop such work until authorized by the Building Inspector to proceed with the work.

the puilding Inspector under the provisions of this ordinance shall expire by limitation and become null and void, if the building or work authorized by such permit is not commenced within 60 days from the date of issuance of said permit, or if the building or work so authorized by such permit is suspended or abandoned at any time after the work is commenced for a period of 60 days. Before work can be re-commenced, a new permit shall be first obtained so to do, and the fee therefor shall be one-half the amount required for a new permit for such work, provided no changes have been made or will be made in the original application and provided further that such suspension or abandonment has not exceeded one year.

## SECTION 6. Penalties.

It shall be unlawful for any person to erect, construct, enlarge, alter, repair, move, improve, convert or demolish any non-habitable buildings or structure within the County of Washoe or cause the same to be done, in violation of any of the provisions of this ordinance.

Any person or persons who shall violate any of the provisions of this ordinance shall be deemed guilty of a misdeameanor and each such person shall be deemed guilty of a separate offense for each and every day or portion thereof during which any violation of any of the provisions of this ordinance is committed, continued or permitted, and upon conviction thereof shall be fined in a sum not to exceed five hundred dollars (\$500) or imprisoned in the county jail for a term not to exceed 6 months or by both such rine and imprisonment.

SECTION 7. Repeals. All ordinances and parts of ordinances in conflict with this ordinance are hereby expressly repealed.
