Russell McDonald, Attorney-at-Law, representing the Washoe County School District, appeared before the Board and presented a RESOLUTION passed and adopted on July 24th. 1956 by the Trustees of the Washoe County School District, declaring an emergency and calling for an election to submit the question of the District's incurring an indebtedness in the amount of \$4,000,000.00 in bonds and whether or not Washoe County should assume all of the outstanding bonding indebtedness of the School Districts. Some discussion followed and upon motion duly seconded and carried by the unanimous vote of the Board it was ordered that the following Ordinance be passed immediately and spread in full upon the minutes. It was further ordered that the copy of the RESOLUTION be placed on file.

SUMMARY - An Ordinance concerning the special school election to be held at the same time as the general election on November 6, 1956, as called by the Board of Trustees of the Washoe County School District.

ORDINANCE No. 50

AN ORDINANCE RATIFYING, APPROVING AND CONFIRMING ACTION HERETOFORE TAKEN BY THE BOARD OF TRUSTEES OF THE WASHOE COUNTY SCHOOL DISTRICT, ITS OFFIC-ERS, AND THE OFFICERS OF WASHOE COUNTY IN CONNECTION WITH THE SPECIAL SCHOOL ELECTION, TO BE HELD AT THE SAME TIME AS THE GENERAL ELECTION ON THE 6TH DAY OF NOVEMBER, 1956, AT WHICH THERE SHALL BE SUBMITTED THE QUES-TION OF THE DISTRICT'S INCURRING AN INDEBTEDNESS IN THE MAXIMUM PRINCIPAL AMOUNT OF \$4,000,000.00, FOR THE PURPOSE OF IMPROVING THE SCHOOL FACILITIES OF SAID DISTRICT, BY CONSTRUCTING NEW SCHOOL BUILDINGS, ENLARGING AND REPAIR-ING EXISTING SCHOOL BUILDINGS, ACQUIRING SCHOOL BUILDING SITES AND ADDITION-AL REAL PROPERTY FOR NECESSARY SCHOOL PURPOSES AND PURCHASING NECESSARY SCHOOL EQUIPMENT THEREFOR, AND THE QUESTION OF ASSUMING THE BONDED INDEBTED-NESS OF THE SCHOOL DISTRICTS AND EDUCATIONAL DISTRICTS WHICH WERE ABOLISHED BY CHAPTER 32, STATUTES OF NEVADA 1956, AND THE TERRITORIES OF WHICH ARE WITHIN THE BOUNDARIES OF THE WASHOE COUNTY SCHOOL DISTRICT; PROVIDING THE PRECINCTS AND POLLING PLACES TO BE USED FOR SAID ELECTION, AND THE APPOINT-MENT OF INSPECTORS AND CLERKS THEREFOR, AND OTHER DETAILS IN CONNECTION THEREWITH; AUTHORIZING THE WRITTEN NOTICE TO THE CLERK OF THE BOARD OF TRUSTEES OF THE WASHOE COUNTY SCHOOL DISTRICT OF THE ACTION HEREIN TAKEN; AND DECLARING AN EMERGENCY.

WHEREAS, the Clerk of the Board of Trustees of the Washoe County School District, in the County of Washoe and State of Nevada, has transmitted certified copies of a certain Resolution adopted and approved by said Board on the 24th day of July, 1956, to the County Clerk and to the Board of County Commissioners of Washoe County; and

WHEREAS, Section 157 of Chapter 32, Statutes of Nevada 1956, provides, in subsection 2 thereof, that immediately upon receipt of a certified copy of the resolution calling a

special school election, the Board of County Commissioners shall take such action as the Board of County Commissioners may deem necessary in accordance with the provisions of subsection 3 of Section 160 of said Chapter 32, and thereupon shall, in writing, notify the Clerk of the Board of Trustees of such action; and

WHEREAS, Subsection 3 of Section 160 of said Chapter 32 provides that the Board of County Commissioners charged with conducting a special school election may, for the purposes of the election, divide the county into special election or consolidated election precincts by consolidating existing precincts, or otherwise, and may change and alter the precincts for such elections, as often as occasion requires; and

WHEREAS, In the opinion of this Board the immediate need of the people of this County for adequate school facilities necessitates that this ordinance be adopted and take effect at the earliest possible date, the Board of County Commissioners has deemed, and does hereby declare, that an emergency exists requiring this ordinance to take effect from and after its passage and publication by title in accordance with law.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE IN THE STATE OF NEVADA, DOES ORDAIN:

Section 1. That all action heretofore taken (not inconsistent with the provisions of this ordinance) by the Board of Trustees of the Washoe County School District, the officers thereof, and the officers of Washoe County, directed toward improving the District's School facilities, by constructing new school buildings, enlarging and repairing existing school buildings, acquiring school building sites and additional real property for necessary school purposes, and purchasing necessary school equipment therefor, and toward assuming the outstanding bonded indebtedness of the school districts and educational districts which were abolished by Chapter 32, Statutes of Nevada 1956, and the territories of which are within the boundaries of the Washoe County School District, be, and the same hereby is, ratified, approved and confirmed, including, without limiting the generality of the foregoing, the adoption by said Board of Trustees of that certain Resolution, on the 24th day of July, 1956, and action taken pursuant thereto.

Section 2. That the precincts for said special school election shall be the same as those designated for the general election to be held in said County on Tuesday, the 6th day of November, 1956.

Section 3. The polling places for said school election shall be those designated for said general election.

Section 4. That at least fifteen days preceding said general election and said special school election, the Board of County Commissioners shall appoint suitable persons who are citizens and qualified voters in Nevada, in Washoe County and in the precinct where they are appointed, at least three such persons to act as inspectors in each precinct and two such persons therein to act as clerks of said election. Said inspectors and clerks shall be the election officers for said election, shall have charge of the ballots on the date of said election, and shall perform such duties in holding said election, and make due return thereof as required by the general election laws of the State of Nevada insofar as the same are not inconsistent with the provisions of said Chapter 32.

Section 5. That said school election shall be conducted in the manner provided by said Chapter 32, by the Resolution, and as nearly as practicable by Chapter 197, Statues of Nevada 1917, as amended, as if it were a county election; and the County Clerk and his deputies shall do all things in connection with said election required by said Chapter 32, as supplemented by the Resolution of the Board of Trustees of the Washoe County School District, and, as nearly as practicable and to the extent not inconsistent with said Chapter 32, by

Chapter 197, Statutes of Nevada, 1917, as amended, including, without limiting the generality of the foregoing, the providing of voting machines, the providing of printed ballots, furnishing of the ballot boxes for the several precincts, and the procuring of any and all necessary materials, equipment and supplies, required by said laws; provided, however, that all expenses incurred in holding the school election so consolidated with said general election shall be borne by the County, but the expenses of printing necessary ballots and forms of affidavits shall be paid by the District, pursuant to Subsection 4, Section 160, Chapter 32, Statutes of Nevada 1956.

Section 6. That the County Clerk shall give notice in writing of the action hereby taken, including that taken by Section 2 and 3 hereof pursuant to Section 159 to said Chapter 32, such notice to be given by transmitting to the Clerk of said Board a certified copy of this ordinance.

Section 7. That the Board of County Commissioners has expressed in the preamble to this ordinance the existence of an emergency, and does hereby find and declare that such emergency does exist, and, consequently, final action shall be taken immediately, and this ordinance shall be in effect from and after its publication as hereinafter provided, and that after this ordinance is signed by the Chairman of said Board and attested and sealed by said County Clerk, this ordinance shall be published by title only, together with the names of the Commissioners voting for or against its passage, and with a statement that typewritten copies of said ordinance are available for inspection by all interested parties at the office of said County Clerk, in the Reno Evening Gazette, a newspaper published and having general circulation in said County, and published daily in the City of Reno therein, at least once a week for a period of two weeks by two insertions, pursuant to Chapter 296, Statues of Nevada 1955, and all laws thereunto enabling, such publication to be in substantially the following form:
