AN ORDINANCE TO AMEND SECTION 4, COUNTY ORDINANCE 51 ENTITLED: "AN ORDINANCE PROVIDING LOCAL REGULATIONS FOR THE SUBDIVISION OF LAND WITHIN THE UNINCORPORATED AREA OF WASHOE COUNTY: PROVIDING FOR THE REVIEW OF TENTATIVE PLATS: PROVIDING PENALTIES FOR THE VIOLA-TION THEREOF AND OTHER MATTERS RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 4 of County Ordinance 51 is hereby amended to add to Section 4 a paragraph numbered 5 to read as follows:

> "5. In addition to any other fee or charge required by law, the subdivider shall pay a fee to the Planning Commission upon filing a tenative subdivision plat. This fee shall be Twenty-five Dollars (\$25.00) for each map plus Fifty Cents (\$.50) for each lot shown thereon."
