NOTICE IS HEREBY GIVEN that Bill 97, an Ordinance to amend Section 4, County Ordinance 51 entitled, "An ordinance providing local regulations for the subdivision of land within the unincorporated area of Washoe County; providing for the review of tentative plats; providing penalties for the violation thereof and other matters relating thereto" was proposed on the 16th day of December, 1963 by Commissioner Streeter and final action of adoption was taken on the 16th day of December, 1963 as an emergency measure by the following vote:

SUMMARY: An ordinance amending Ordinance 51, Section 4 to provide for a fee to the Regional Planning Commission upon filing a tentative Subdivision Plat.

ORDINANCE NO. 51

AN ORDINANCE TO AMEND SECTION 4, COUNTY ORDINANCE 51 ENTITLED: "AN ORDINANCE PROVIDING LOCAL REGULATIONS FOR THE SUBDIVISION OF LAND WITHIN THE UNINCORPORATED AREA OF WASHOE COUNTY: PROVIDING FOR THE REVIEW OF TENTATIVE PLATS: PROVIDING PENALTIES FOR THE VIOLATION THEREOF AND OTHER MATTERS RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 4 of County Ordinance 51 is hereby amended to add to Section 4 a paragraph numbered 5 to read as follows:

"5. In addition to any other fee or charge required by law, the subdivider shall pay a fee to the Planning Commission upon filing a tentative subdivision plat. This fee shall be Twenty-five Dollars (\$25.00) for each map plus Fifty Cents (\$.50) for each lot shown thereon."

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
