AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED: "AN ORDI-NANCE REGULATING THE PLACEMENT AND CONSTRUCTION OF OUT-DOOR ADVERTISING STRUCTURES IN THE UNINCORPORATED AREA OF THE COUNTY OF WASHOE; PROVIDING FOR THE ADMINISTRA-TION THEREOF, THE LICENSING OF FIRMS AND INDIVIDUALS WHO CONSTRUCT AND/OR PLACE ADVERTISING DISPLAYS, THE ESTA-BLISHMENT AND COLLECTION OF FEES: FURTHER PROVIDING FOR THE VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELAT-ING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 7, Paragraph numbered 8 of County Ordinance No. 53 is hereby amended to read as follows:

> "Permit fees shall be based on the following schedule: Initial fee is an amount equal to the building permit fee prescribed by the Uniform Building Code of Washoe County as adopted by County Ordinance No. 83, plus 50¢ which will apply on the first year permit and, thereafter, 50¢ per advertising display per year."

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
