NOTICE IS HEREBY GIVEN that Bill
No. 91, Ordinance No. 53, an Ordinance
to amend an ordinance entitled: "An
Ordinance regulating the placement and
construction of outdoor advertising struc-
tures in the unincorporated area of the
County of Washoe; providing for the ad-
ministration thereof, the licensing of
firms and individuals who construct and
erect or place advertising displays, the estab-
lishment and collection of fees; further
providing for the violation thereof; and
other matters properly relating thereto,"
was passed on the 5th day of October,
1963, by Commissioner McKissick, and
was passed on said date as an emergency
measure by the following vote of the
Board of County Commissioners:

ORDINANCE NO. 53

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED: "AN ORDINANCE REGULATING THE PLACEMENT AND CONSTRUCTION OF OUTDOOR ADVERTISING STRUCTURES IN THE UNINCORPORATED AREA OF THE COUNTY OF WASHOE; PROVIDING FOR THE ADMINISTRATION THEREOF, THE LICENSING OF FIRMS AND INDIVIDUALS WHO CONSTRUCT AND/OR PLACE ADVERTISING DISPLAYS, THE ESTABLISHMENT AND COLLECTION OF FEES: FURTHER PROVIDING FOR THE VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 7, Paragraph numbered 8 of County Ordinance No. 53 is hereby amended to read as follows:

"Permit fees shall be based on the following schedule: Initial fee is an amount equal to the building permit fee prescribed by the Uniform Building Code of Washoe County as adopted by County Ordinance No. 83, plus 50¢ which will apply on the first year permit and, thereafter, 50¢ per advertising display per year."

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
