AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NO. 55 ENTITLED "AN OR-DINANCE AUTHORIZING THE COUNTY CLERK TO CHARGE AND COLLECT AN ADDI-TIONAL FEE FOR MARRIAGE LICENSES ISSUED BEFORE OR AFTER REGULAR OFFICE HOURS. PROVIDING FOR THE PAYMENT THEREOF TO THE COUNTY GENERAL FUND AND OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OR WASHOE DO ORDAIN:

SECTION 1. Section 2 of Ordinance No. 55 is hereby amended to read as follows:

SECTION 2. Regular office hours, for the purpose of this Ordinance, shall be from the hours of 8:00 o'clock a.m. to 5:00 o'clock p.m., Monday to and including Friday, legal holidays and nonjudicial days excluded.

SECTION 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
