## INTRODUCED BY COMMISSIONER Peterson

AN ORDINANCE AUTHORIZING THE COUNTY CLERK TO CHARGE AND COLLECT AN ADDITIONAL FEE FOR MARKIAGE LICENSES ISSUED BEFORE AND AFTER REGULAR OFFICE HOURS, BY AMENDING ORDINANCE NO. 55; SECTION 1; PRESCRIBING OTHER DETAILS IN CONNECTION THEREWITH; AND DECLARING AN EMERGENCY.

has adopted Ordinance No. 55, entitled "An Ordinance authorizing the County Clerk to charge and collect an additional fee for marriage licenses issued before or after regular office hours. Providing for the payment thereof to the County General Fund and other matters properly relating thereto," passed and adopted on the 20th. day of April 1957; and

whereas, by reason of the inadequacy of County revenues and of the necessity of immediately raising funds, the Board of County Commissioners has determined, and does hereby declare, that an emergency exists requiring this Ordinance to take effect from and after its passage and publication by title in accordance with law.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE, IN THE STATE OF NEVADA, DOES ORDAIN:

Section 1. That Ordinance No. 55, Section one (1) be, and the same hereby is, amended to read as follows:

Section 1: From and after the passage of this Ordinance, the County Clerk of Washoe County shall charge and collect a fee of FIVE DOLLARS (\$5.00) lawful money of the United States, in additional to all other fees, as provided by statute, upon issuing

a marriage license after regular office hours. Section 2. That the Board of County Commissioners has expressed in the preamble to this Ordinance the existance of an emergency, and does hereby find and declare that such emergency does exist, and, consequently, final action shall be taken immediately, and this Ordinance shall be in effect from and after its publication as required by law.
