 District No. 1 of the Land Use Plan of Washoe County is hereby amended in the manner shown on the map labeled 'Change of Land Use District Case #C-13-67W', such map on file in the offices of the Regional Planning Commission of Reno, Sparks and Washoe County, and which map is hereby made a part of this Ordinance.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
