SUMMARY: Amends Ordinance No. 57 by authorizing temporary off-site subdivision real estate offices in Agricultural and Residential Land Use Districts, subject to the issuance of a Special Use Permit.

AN ORDINANCE TO AMEND WASHOE COUNTY ORDINANCE NO. 57 BY AUTHORIZING TEMPORARY OFF-SITE SUBDIVISION REAL ESTATE OFFICES IN AGRICULTURAL AND RESIDENTIAL LAND USE DISTRICTS, SUBJECT TO THE ISSUANCE OF A SPECIAL USE PERMIT.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Article 5, Section Bl of Ordinance No. 57 is hereby amended to read as follows:

- B. Temporary Real Estate Offices and Signs:
 - Subdivision offices and sales signs: In any agricultural or residential Land Use District, temporary real estate offices may be permitted within a subdivision, provided that the general real estate business shall not be conducted at such offices. Temporary off-site real estate offices for subdivision sales may be permitted, subject to the issuance of a Special Use Permit reviewed by the Board of Adjustment. General real estate business shall not be conducted at such offices. Temporary signs, not to exceed in the aggregate four hundred square feet in size, may be permitted within a subdivision for the purpose of selling lots or houses within such subdivision. Such offices and signs shall be removed at such time as the original sales program has resulted in the sale of 90% of the lots in such subdivision or subdivisions.

SECTION 2.
This Ordinance shall be in full force and effect from and after its approval, passage and publication as prescribed by NRS 244.100.
