NOTICE is hereby given that an Ordinance regulating the operation of motorboats upon waters in the County of Washoe, State of Nevada and other matters related thereto, was proposed on May 20th, 1958, by Commissioner Capurro; final action of adoption was taken on June 5th, 1958, by the following vote:
Ayes: Commissioners: Kleppe, Capurro and Peterson.
Nays: Commissioners: None

This ordinance shall be in full force and effect from and after June 29th, 1958.

Ordinance No. 58

1 SUMMARY - For all motorboats: Requires all motorboats operated
 2 upon any waters within Washoe County to be equipped in accordance
 3 with Federal, State and County laws in effect at the time of the
 4 enactment of the ordinance and makes it a misdemeanor to operate
 5 a motorboat or vessel in a reckless or negligent manner, and
 6 further, requiring licensing of motorboats when carrying passen-
 7 gers for hire and making it a misdemeanor to operate a motorboat
 8 or vessel in a reckless or negligent manner and other matters
 9 properly relating thereto.

6 AN ACT REGULATING THE OPERATION OF MOTORBOATS
 7 UPON WATERS IN THE COUNTY OF WASHOE, STATE OF
 8 NEVADA AND OTHER MATTERS RELATED THERETO.

8 THE BOARD OF COUNTY COMMISSIONERS
 9 OF WASHOE COUNTY DO ORDAIN:

10 It shall be unlawful and a misdemeanor -

11 a. For any motorboat to be operated upon any waters
 12 within the limits of this County which is not equipped and
 13 operated in accordance with the Federal, State or County laws
 14 and regulations in effect as of the effective date of this
 15 ordinance for operation on the navigable waters of the United
 16 States.

14 b. For any motorboat while carrying passengers for
 15 hire to be operated or navigated by a person who is not licensed
 16 for such service.

16 c. For any person to operate a motorboat or vessel in
 17 a reckless or negligent manner so as to endanger the life, limb
 18 or property of any person.

18 In essence this primarily would simply make it a County
 19 misdemeanor to violate Federal laws and regulations governing
 20 motorboat operation.
