Was proposed on May 20th. 1958, by Commissioner Capurro; final action of adoption was taken on June 5th. 1958, by the following vote:

This ordinance shall be in full force and effect from and after June 39th. 1958.

Ordinance No. 58

SUMMARY - For all motorboats: Requires all motorboats operated upon any waters within Washoe County to be equipped in accordance with Federal, State and County laws in effect at the time of the enactment of the ordinance and makes it a misdemeanor to operate a motorboat or vessel in a reckless or negligent manner, and further, requiring licensing of motorboats when carrying passengers for hire and making it a misdemeanor to operate a motorboat or vessel in a reckless or negligent manner and other matters properly relating thereto.

AN ACT REGULATING THE OPERATION OF MOTORBOATS UPON WATERS IN THE COUNTY OF WASHOE, STATE OF NEVADA AND OTHER MATTERS RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

It shall be unlawful and a misdemeanor -

a. For any motorboat to be operated upon any waters within the limits of this County which is not equipped and operated in accordance with the Federal, State of County laws and regulations in effect as of the effective date of this ordinance for operation on the navigable waters of the United States.

b. For any motorboat while carrying passengers for hire to be operated or navigated by a person who is not licensed for such service.

16 a reckless or negligent manner so as to-endanger the life, limb or property of any person.

In essence this primarily would simply make it a County misdemeanor to violate Federal laws and regulations governing motorboat operation.
