ORDINANCE NO. 6/

AN ORDINANCE DEFINING A REGIONAL PLANNING DISTRICT: EMPOWERING A REGIONAL PLANNING COMMISSION TO ACT FOR AND ON BEHALF
OF THE COUNTY OF WASHOE IN ALL PLANNING DUTIES AND PLANNING
FUNCTIONS: PROVIDING FOR THE APPOINTMENT AND COMPENSATION
OF MEMBERS: THE APPROPRIATION OF FUNDS FOR EXPENSES THEREOF:
AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN: 11 Section 1. Washoe County a part of regional planning district. 12 That portion of Washoe County lying westerly of dividing crest of the Sierra Nevada Mountains and comprising the watershed area of 13 the Lake Tahoe basin is hereby declared to be part of a regional 14 planning district. 15 Section 2. Representation of County on Planning Commission. 16 The County of Washoe shall be represented in a Regional Planning 17 Commission, which commission is hereby authorized to act for and 18 on behalf of the County of Washoe as a Planning Commission which 19 shall fulfill all of the duties and functions of a Planning Com-20 mission as set forth in the enabling Act, Chapter 278. 21 IRS and all acts amendatory thereto. 22 Section 3. County participation conditioned upon membership. 23 Participation of the County of Washoe in the Regional Planning 24 Commission as set forth in this ordinance is authorized only under 25 the condition that the total membership of said Commission shall 26 consist of 6 members each of whom shall be appointed to a term of 27 6 years or until his successor takes office (except that the 28 respective terms of 3 of the members first appointed shall be 4 years) and further conditioned upon the participation of the

Counties of Douglas and Ormsby in said Commission. Section 4. Appointments, Terms of County Members. The Board of County Commissioners shall appoint 2 members of the ·Regional Planning Commission. One such member shall be appointed for a term of 6 years, the other appointed for a term of 4 years, with all subsequent appointments for a full term of 6 years. Section 5. Members, service without compensation, removal Vacancies. All members of the Regional Planning Commission shall serve with-

out compensation. They may be removed, after public hearing, by a majority vote of the Board of County Commissioners for inefficiency, neglect of duty or malfeasance of office. Vacancies occuring otherwise than thru the expiration of term shall be filled for the unexpired term. Section 6. Appropriation of Funds for Commission Use.

The Board of County Commissioners may appropriate funds annually for the use of the Regional Planning Commission, such funds to be made a part of the budget of Washoe County. The Regional Planning Commission shall have no authority to expend any funds of Washoe County in excess of those as appropriated, but may negotiate for gifts, Federal and State grants and other funds and may expend same within the total amounts as acquired.

Section 7. Repeal.

All ordinances and parts of ordinances in conflict herewith are hereby repealed.
